ORDINANCE NO. 8769

AN ORDINANCE relating to the annexation of an area known as 88-1 Parcel B to Skyway Water and Sewer District, for sewer service only.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as 88-1 Parcel B for sewer service only to Skyway Water and Sewer District was filed with the county council effective October 14, 1988.
- 2. Skyway Water and Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 88-10-86 concurred with the proposed annexation.
- 3. Skyway Water and Sewer District filed a Declaration of Non-significant Impact dated August 31, 1988, on the proposed annexation.
- 4. The county council held a public hearing on the 5% day of 0% and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Skyway Water and Sewer District of the area known as 88-1 Parcel B and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on 88-1 Parcel B.

SECTION 2. The Skyway Water and Sewer District is the appropriate entity to serve the area proposed to be annexed for sewer service only.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

SECTION 4. The area known as 88-1 Parcel B to be annexed is described as follows:

Legal description of proposed Skyway annexation as taken from descriptions supplied by King County.

Beginning at the Northwest corner of the Southeast quarter of the Northwest quarter of Section 12, Township 23, Range 4, W.M., King County, Washington;
