ORDINANCE NO. 8889

AN ORDINANCE relating to the annexation of an area known as Oxbow to Val Vue Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Oxbow to Val Vue Sewer District was filed with the county council effective February 21, 1989.

2. Val Vue Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 86-30 concurred with the proposed annexation.

3. Val Vue Sewer District filed a Declaration of Non-significant Impact dated December 29, 1988, on the proposed annexation.

4. The county council held a public hearing on the 20th day of March, 19 89 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Val Vue Sewer District of the area known as Oxbow and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on Oxbow.

SECTION 2. The Val Vue Sewer District is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

1 SECTION 4. The area known as Oxbow to be annexed is described
2 as follows:

4 That portion of Section 4 Township 23 North, Range 4 East
5 W.M., King County, Washington.

6 Beginning at the center of Section 4. Thence South along the
7 North-South centerline of said Section 4 to the centerline of West
8 Marginal Way;

9 Thence Southerly along said centerline of said West Marginal
10 Way to the South line of the Southeast quarter of said Section 4;

11 Thence East along said South line of said Section 4 to the
12 Thread of the Duwamish River;

13 Thence Northerly, Northeasterly and Northwesterly along said
14 thread to the South line of the Northeast quarter of said Section
15 4;


16 Thence continuing along said thread Northwesterly to said
17 North-South centerline of said Section 4;

18 Thence South along said centerline of said Section 4 to the
19 Point of Beginning.


