10 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

11 SECTION 1. There is hereby approved and adopted an appropriation of  
12 \$76,619 to Block Grant Project No. C89184 Springwood Park substituting existing  
13 Community Development Block Grant funds with \$58,000 in Current Expense Funds  
14 for Project No. C89165 Bothell/Woodinville Clinic, Project No. C89188 Federal  
15 Way Community Clinic and Project No. C89308 Redmond Food Bank; and with  
16 \$18,619 in Emergency Shelter Grant funds for Project No. C89172 North King  
17 County Emergency Shelter.






