ORDINANCE NO. 8989

AN ORDINANCE relating to the annexation of an area known as W-88-1 to Sammamish Plateau Water and Sewer District for <u>water</u> service only.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as W-88-1 to Sammamish Plateau Water and Sewer District was filed with the county council effective April 25, 1989.
- 2. Sammamish Plateau Water and Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. A-919 concurred with the proposed annexation for water service only.
- 3. Sammamish Plateau Water and Sewer District filed a Declaration of Non-significant Impact dated August 29, 1988 on the proposed annexation.
- 4. The county council held a public hearing on the <u>30</u>ⁿ day of <u>May</u>, 19 89 and has considered the criteria set forth in R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Sammamish Plateau Water and Sewer District of the area known as W-88-1 and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 57.02.040 as described in the attached King County Council Annexation Report on W-88-1 for water service only.

SECTION 2. Sammamish Plateau Water and Sewer District is the appropriate entity to serve the area proposed to be annexed for water service only.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.
