6 AN ORDINANCE making a supplemental appropriation of \$40,500
7 to executive administration, \$16,000 to roads-operating,
8 \$4,000 to surface water management, \$16,000 to solid waste,
9 \$4,000 to airport, and \$14,500 to stadium administration from
10 Special Programs Executive Contingency, and the respective
11 fund balances to support Minority/Women's Business Program
12 consultant contracts; and amending Ordinance No. 8802,
13 Sections 24, 38, 54, 55, 76, 77 and 78 as amended; and
14 declaring an emergency.

15 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

16 SECTION 1. There is hereby approved and adopted a supplemental appropria-
17 tion of \$40,500 to executive administration, \$16,000 to roads operating,
18 \$4,000 to surface water management, \$16,000 to solid waste, \$4,000 to airport,
19 and \$14,500 to stadium administration, from Special Programs Executive
20 Contingency, and the respective fund balances, to support Minority/Women's
21 Business Program consultant contracts.

2 by adding thereto and inserting therein the following:

3 SURFACE WATER MANAGEMENT - From the Surface Water Management Fund there is
4 hereby appropriated to:

5 Surface Water Management \$4,000

6 SECTION 5. Ordinance No. 8802, Section 76, as amended, is hereby amended
7 by adding thereto and inserting therein the following:

8 SOLID WASTE - From the Solid Waste Fund there is hereby appropriated to:

9 Solid Waste \$16,000

10 SECTION 6. Ordinance No. 8802, Section 77, as amended, is hereby amended
11 by adding thereto and inserting therein the following:

12 AIRPORT - From the Airport Operating Fund there is hereby appropriated to:

13 Airport \$4,000

14 SECTION 7. Ordinance No. 8802, Section 78 is hereby amended by adding
15 thereto and inserting therein the following:

16 STADIUM ADMINISTRATION - From the Stadium Operating Fund there is hereby
17 appropriated to:

18 Stadium Administration \$14,500

19 SECTION 8. Ordinance No. 8802, Section 38, as amended, is hereby amended
20 by adding thereto and inserting therein the following:

21 SPECIAL PROGRAMS - EXECUTIVE CONTINGENCY - From Special Programs
22 Executive Contingency, there is hereby disappropriated:


23 Special Programs-Executive Contingency (\$40,500)
