ORDINANCE NO. 9052

AN ORDINANCE relating to the annexation of an area known as Bondo to Cascade View Water District.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as Bondo to Cascade View Water District was filed with the county council effective June 20, 1989.
- 2. Cascade View Water District has found the petition for annexation to be sufficient and has, by Resolution No. 139 concurred with the proposed annexation.
- 3. Cascade View Water District filed a Declaration of Non-significant Impact dated March 21, 1989, on the proposed annexation.
- 4. The county council held a public hearing on the 24th day of _______, 1989 and has considered the criteria set forth in R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Cascade View Water District of the area known as Bondo and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 57.02.040 as described in the attached King County Council Annexation Report on Bondo.

 $\underline{\sf SECTION\ 2}$. Cascade View Water District is the appropriate entity to serve the area proposed to be annexed.

Completion of this annexation does not constitute 2 county approval or disapproval of any other permits, certifica-3 tions, or actions necessary to provide service to this annexation 4 area. 5 SECTION 4.
