ORDINANCE NO. 907

AN ORDINANCE approving the Northeast Sammamish Sewer and Water District Amendment to the Comprehensive Sewer Plan, repealing Ordinance 8843.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 8843 is hereby repealed.

SECTION 2. Findings. The King County council finds that:

- 1. On April 15, 1988, a Declaration of Non-Significance was issued by the Board of Commissioners of Northeast Sammamish Sewer and Water District.
- 2. On May 12, 1988, the Board of Commissioners of the Northeast Sammamish Sewer and Water District passed Resolution 1563, adopting the District's 1988 Comprehensive Sewer Plan.
- 3. On August 9, 1988, the Utilities Technical Review Committee reviewed the proposed Plan and recommended approval.
- 4. On January 30, 1989, King County Ordinance 8843 was adopted disapproving the proposed Northeast Sammamish Sewer and Water District Comprehensive Sewer Plan, based on the unacceptable environmental impacts and financial hardships imposed upon the residents within proposed ULID LSS 5.
- 5. On June 21, 1989, the Utilities Technical Review Committee reviewed amendments to the proposed Comprehensive Sewer Plan and recommended approval of the Plan, based on revisions to proposed ULID LSS-5 which appear to be more acceptable to the majority of residents.

In a July 19, 1989 letter to the council, the Board of Commissioners of the Northeast Sammamish Sewer and Water District confirm that..."the Commissioners will allow property owners within the proposed ULID boundary the opportunity to not participate in the ULID thus resulting in no assessment on their property and no sewer service from the sewer improvement. Property owners electing not to participate may be permitted to connect at a later time upon payment of connection charges, which are likely to exceed the assessment amounts under the proposed ULID." SECTION 3. The 1988 Northeast Sammamish Sewer and Water District Comprehensive Sewer Plan is hereby approved. The District's new provisions for ULID LSS-5 now address the concerns expressed by the county council which were the basis for the disapproval of the proposed sewer plan by Ordinance 8843 in January 1989.
