# ORDINANCE NO. 9129

AN ORDINANCE authorizing condemnation of property for the Cemetery Retention/Detention Pond.

## STATEMENT OF FACTS

- 1. The King County council, on December 21, 1988 by Ordinance No. 8802 and as amended, did adopt the 1989 Annual Budget for King County and did provide therein for the Capital Budget and Program, which included Surface and Storm Water Management Fund No. 318.
- 2. The King County Surface and Storm Water Management Construction Program did adopt and provided therein for the acquisition and construction of the Cemetery Retention/Detention Pond facility.
- 3. In order to acquire the property and property rights required to lay out and construct the retention/detention facility known as Cemetery Regional Pond, it is necessary for King County to condemn certain lands and property rights and rights in property for public purposes as hereinafter more particularly set forth.
- 4. The King County council finds that the public health, safety, necessity, convenience, and welfare demand that the Cemetery Retention/Detention facility be constructed in accordance with the Surface and Storm Water Management Construction program, and that certain properties, property rights, and rights in property be condemned, appropriated, taken, and damaged for the construction of said retention/detention facility as provided in this ordinance.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The King County council has deemed it necessary and in the best interest of the citizens of King County that the lands hereinafter described in the attached Exhibit "A," and other property rights and/or rights in property be condemned, appropriated, taken, and damaged for the purpose of constructing the Cemetery Retention/Detention facility, subject to the making or paying of just compensation to the owners thereof in the manner provided by law.

#### DRAINAGE EASEMENT

#### Pacific Trust Company, Trustee for Stacey E. Voorhees - Parcel 27(3A)

Commencing at the Northwest corner of the Northwest 1/4 of the Northwest 1/4 of the Northwest 1/4 of Section 13, Township 23, North, Range 5 East, W. M., in King County, Washington;

thence East 230 feet;

thence South 660 feet, more or less, to the South line of said subdivision; thence West 230 feet;

thence North 660 feet;

EXCEPT the Westerly 30 feet thereof, deeded to King County by Deed recorded under King County Recording No. 3189344; AND EXCEPT the Northerly 333 feet.

Contains an area of 63,625 sq. ft., or 1.46 acres, more or less.

## <u>Pacific Trust Company, Trustee for Stacey E. Voorhees - Parcel 27(4A)</u>

That portion of Tract X described below lying Southeasterly and Easterly of the following described line:
