AN ORDINANCE relating to Vashon-Maury Island, redesignating roads and designating previously undesignated roads; repealing Resolution 16622 (part) as pertaining to Vashon-Maury Island, and as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. A. The Vashon-Maury Island road designation plan, which is attached as Appendix A to this ordinance and illustrated in the official Vashon-Maury Island road index maps attached as Appendix B to this ordinance, is adopted as the official overall system of road designations for Vashon-Maury Island.

- B. The official copy of the Vashon-Maury Island road designation plan and maps are to remain in the offices of the King County building and land development division.
- C. All subsequent road designations and redesignations for Vashon-Maury Island shall be processed as set forth in K.C.C. 16.08.010-090.

SECTION 2. Resolution 16622, as amended (part), as pertaining to Vashon-Maury Island, and all other formal or informal road designations on Vashon-Maury Island, are hereby repealed.

SECTION 3. Should any section, subsection, paragraph, sentence, clause or phrase of this ordinance be declared unconstitutional or invalid for any reason, such decision shall not affect the validity of the remaining portion of this ordinance.

SECTION 4. K.C.C. 16.08 was not intended to apply to 1 areawide street designations. It was intended to be used for name changes to specific streets initiated by property owners. 3 For this reason, the public notice procedures of K.C.C. 16.08 4 will not be followed. Notice to persons affected by this 5 ordinance has been accomplished by postcards detailing the process, extensive local newspaper coverage, and active community 7 involvement. Subsequent notice to property owners after the 8 passage of this ordinance will be done by the building and land 9 development division in conjunction with the U.S. Postal Service. 10 SECTION 5. VASHON-MAURY ISLAND ADDRESSING PROJECT

AND ROAD DESIGNATION PLAN

King County Building and Land Development Division (BALD) is now completing its approximately year-long project to designate roads (give them numbers and names) and assign building addresses on Vashon-Maury Island. The island is the last remaining sizable area in populated King County where the established grid system has not been fully in use.

For the sake of public safety, uniformity, efficient administration and public convenience, King County has always looked toward extending the grid system to the island. In the past, however, residents were apprehensive that changing road names to numbers would diminish the island's charm and tradition. As explained below, BALD believes that the island public is now willing to accept uniform road designations and addresses.

Background and History

King County's policy is to designate roads and assign addresses according to the grid system first adopted in 1938. Most King County roads were designated and addresses assigned in the early 1970s, and new roads and buildings since then fit into the system. Over the years, some Vashon-Maury roads have been designated and signed, and addresses have been assigned when BALD issued building permits. Many of the road designations have never actually been used on the island, however. Geographical addresses are not in general use, mail delivery is by route and box, and many residents have post office boxes.

Since King County adopted the 911 emergency communications system in late 1985, interest in standardizing road designations and addresses has grown among the island public, as well as among those who provide emergency services. Precious minutes, sometimes lives, can be saved if an aid car or police car can hurry to a known intersection, rather than check a map or an index -- or depend on vague descriptions of neighboring landmarks.

There was some interest in including funding for the project in a recent budget, but the attempt failed. Early in the current administration, County Executive Tim Hill suggested at a Vashon-Maury Community Council meeting that perhaps a community-based effort could succeed at a lower cost and be more acceptable to islanders. On December 21, 1987, the community council held a public meeting on the issue. Following the meeting, where various points of view were expressed in a lively discussion, the community council president appointed an addressing committee composed of island residents. Their charge was to research existing names, determine which roads should be designated by names and which by numbers, and propose those designations to the community council and BALD. The committee included representatives of history- and tradition-minded residents, as well as those from emergency and delivery services. The committee's effort was guided by the following general principles:

1. Names should reflect history or geography, be accurate, and be in the most simple form.

- 2. Each road should have one designation (many island roads have been known by two or more names).
- 3. Designations should not honor living persons.
- 4. Logic demanded that some existing names should be numerical designations.

Recognizing that it would be better to use names agreed upon by the community -- most of them in continuous use for many years -- than to continue with the existing chaotic situation, BALD has cooperated with the committee. At the same time, we have successfully urged that a majority of the roads be numbered, and that names be limited to the traditional and familiar, keeping in mind the needs of emergency and delivery personnel, as well as others looking for addresses.

The Project

The addressing committee met twice monthly from March through September 1988 to pursue its tasks. BALD personnel attended committee meetings, but generally did not participate in the discussions. The full community council held public meetings on June 13 and 20, in different parts of the island, to gather public input in addition to that already collected. By August, the committee's initial task was essentially complete -- designations had been agreed upon for all qualified roads. Appendix B is a list of the named roads, and Appendix D briefly describes the historical significance of the names.

In August 1988, BALD hired a staff of six island residents as geodata technicians and geodata recorders. They have been supervised by a BALD project manager, who has visited the island usually weekly, and kept in touch by phone daily. In September a temporary office opened in the Ober Park Building; it has been staffed during regular office hours since. After training by BALD's permanent addressing staff, the technicians first located all buildings and driveways using a foot meter, and then went on to assign addresses to residences and businesses.

As a result of field checking, the staff found some places where technical considerations made the proposed road designations impractical. Staff and committee met together monthly through December, discussing these problems and reaching satisfactory compromises. Meanwhile, BALD's regular addressing staff reviewed the Vashon staff's field work and mapping and helped with problems and unusual situations.

Public Review

On November 21, 1988 the community council held a public meeting on the proposed designations. A map showing them was published in advance in the local newspaper, the <u>Vashon-Maury Island Beachcomber</u>, and also was posted in public places. The newspaper notice urged citizens to send any further road designation suggestions to the community council -- the last chance. A mailing by BALD was sent to the approximately 4,300 households and businesses on the island which receive mail, announcing the public meeting and letting recipients know that this was their chance to comment on street designations. The mailing also informed people that their addresses would be changing from rural routes and box numbers to street addresses based on the King County grid.

Those people attending the community council meeting voted to recommend changing some road designations from numbers to names. The addressing committee, addressing technicians and geodata technicians found almost all of these changes to be feasible. The final result is that approximately one-third of Vashon-Maury Island's roads are proposed to be designated by names, the rest by numbers. See Appendix A-1 for a map and Appendices A-2 and C for lists of all designated roads.

In addition to public meetings and committee work, more than 50 articles and letters from various sources published in the <u>Beachcomber</u> have helped keep the project in the public eye. On June 1, 1989, the <u>Beachcomber</u> published the map (now Appendix A-1) showing all the proposed road designations, with an informative article on the addressing process.

Road Designation Plan

The road designation plan which is the result of the cooperative efforts of the Vashon-Maury Community Council Addressing Committee and BALD staff must be acted upon by the King County Council before it can become effective. Although individual building addresses do not need Council action, they cannot go into effect until road designations have been settled.

Proposed road designations are illustrated on a large, three-sheet Road Index Map of Vashon-Maury Island which is Appendix B to the road designation ordinance. It will be available at the appropriate Council meetings and hearings and will thereafter remain in BALD's offices.

The map entitled Proposed Vashon-Maury Island Road Designations, attached hereto as Appendix A-1, together with Appendix A-2, the Vashon-Maury Island Road Map Index, contains the same information.

Environmental Review

A SEPA checklist was prepared, and a Declaration of Non-Significance was issued on June 29, 1989. The public comment and appeal period ended on July 19, and no appeals were filed.

Future Related Activities

After the proposed ordinance is acted upon, this plan will become official policy for all of Vashon-Maury Island. Over time, it can be updated by the King County Council under the provisions of KCC 16.08, Road Names and Addressing Buildings.


To fully implement the addressing project, the following steps will be needed:

- 1. New road signs must be fabricated and installed by Public Works before new addresses can become effective. A draft ordinance appropriating funds for this purpose is included in this package.
- 2. BALD must notify owners and occupants of buildings of their new addresses.
- 3. BALD must notify public agencies and utilities of new addresses on the island.

Those involved in the addressing project have worked throughout with various King County agencies, such as Public Works, Assessments, Records and Elections, and Systems Services to help ensure that the project does not disrupt their work and that the results will be convenient for their use. Efforts have also been made to keep other interested parties, such as the Postal Service and utility companies, informed and involved.

BALD's major effort will conclude with notification of addresses, but some minor support will be provided to such community efforts as:

- 1. Computerized upgrading of addresses for emergency call-ins and responses by local emergency services.
- 2. Changing by the U.S. Postal Service to use of the new addresses for mail delivery. Information on requirements for new numbers on mailboxes and related matters must be disseminated.
- 3. Programs to encourage building owners and residents to post their new addresses at building entrances, as required by the King County Code (K.C.C. 16.08.050). Some island organization may offer the service of mounting addresses.
- 4. Educational programs with special attention to schools, the elderly, and the disabled to inform everyone of the necessity of using new addresses and to be sure all understand the use of the 911 system.

HISTORICAL SOURCES OF VASHON-MAURY ISLAND ROAD NAMES

ASTA LANE: Named for early landowner, Asta Schade.

BACHELOR ROAD: Named for early landowner, James Bachelor, who settled on that part of the island in 1901.

BANK ROAD: Named in 1911 when Vashon's first bank was built at the junction of this road and the Vashon Highway.

BATES ROAD: William Bates of Montana settled on the west side in 1913.

BATES WALK: To the walk-ins along the beach south of the west end of Bates Road.

BAYVIEW DRIVE: Named in 1920 for its picturesque view.

BEALL ROAD: The Beall family and H. Harrington have operated commercial greenhouses on this road since 1910.

BETHEL LANE: The Bethel Evangelical Free Church bought land and established a church in 1927.

BILOXI ROAD: This name was given by an early resident (Ruth Kellogg) in honor of her home in Mississippi.

BUNKER TRAIL: Mr. Bunker lived at one end. A related Mr. Bunker lived at the other end. The trail was built by WPA in 1935-36.

BURMA ROAD: Dubbed Burma Road by the folks who built it because of its resemblance to its namesake.

BURTON DRIVE: Requested by area residents, the name derives from a pioneer wife who came from Burton-upon-Trent, England.

CAMP SEALTH ROAD: Camp Fire Girls acquired land for a permanent camp in 1921 and named it Camp Sealth.

CAREY ROAD: The road's builder and early resident was Roland Carey.

CASTER ROAD: Named in honor of Mr. and Mrs. Joseph Caster, it passes through the land they owned from approximately 1902 to 1930.

CEDARHURST ROAD: So named by early residents because of the number of tall cedars there.

CEMETERY ROAD: The Vashon cemetery, established in 1890, is located on this road.

CHAUTAUQUA BEACH ROAD: Established by the Chautauqua Assembly in 1888.

Chautauqua means "jumping fish" in the Algonquian Indian language.

COLUMBIA AVENUE: The Columbia School was built in 1897.

COMMONS ROAD: This road is located in a "common section," established in 1864 for a school or other public usage.

CORBIN BEACH ROAD: Harry S. Corbin was a pioneer settler who built the road to Corbin Beach during the early part of the century.

COVE ROAD: Established in pioneer days to connect Vashon in the east with the Cove area on the west shore.

COWAN ROAD: A.D. Cowan was the first President of the Vashon Steamboat Company, started in 1908.

CRESCENT DRIVE: Named by Perry Hansen. In 1925 the old Westside Highway curved past a mission and Perry Hansen's house. The highway was later straightened out, creating Crescent Drive.

CROSS LANDING ROAD: William Cross settled on the west side of the island in 1893.

CUNLIFFE ROAD: Named for Harold Cunliffe, who lived there from 1911 until the early 1950s.

DEPPMAN ROAD: Charles F. Deppman and Tim Clarke founded Vashon Auto Freight in 1903.

DILWORTH ROAD: Rev. R.B. Dilworth settled here with his family in 1884.

DOCK STREET: Named after the marine businesses that were established in Dockton.

DOCKTON ROAD: In 1924 a road was built to replace the difficult overland trail route from Portage to Dockton, a thriving industrial community since 1890.

DOLPHIN POINT ROAD: This road is located on Dolphin Point.

DOLPHIN POINT TRAIL: To the walk-ins along the beach south of Dolphin Point Road.

DUGWAY ROAD: Named after the way the road was created. This was the first road from Quartermaster toward Vashon.

ELISHA LANE: Named for Elisha Morgan, who owned and operated a poultry ranch and peach orchard on this hill.

ELLISPORT ROAD: Rev. Jacob F. Ellis owned 167 acres at what is now Ellisport in 1880.

GLEN ACRES ROAD: Glen Acres is the name given to the area when it was first platted in 1910.

GLEN LANDING ROAD: Requested by residents; there was at one time a boat landing at the end of this short road in the Glen Acres district.

GOLD BEACH DRIVE: Gold Beach was platted in 1967.

GORSUCH ROAD: J.C. Gorsuch and family arrived in 1885 and bought land north of what is now Vashon Town. F.W. Gorsuch opened the first store at Vashon Town in 1890.

HAKE ROAD: The Hake family has lived in the area since 1916. David and Alice Hake owned the old Mansanita Clubhouse as their residence during the 1930s.

HARBOR DRIVE: Curving along the northern part of the Burton Peninsula, it overlooks Quartermaster Harbor.

HAWTHORNE LANE: Named by residents of the area.

HIGHLAND AVENUE: Named by residents of the area.

KINGSBURY ROAD: A.D. Kingsbury settled on Maury with his family in 1889 and operated a logging business.

KLAHANIE ROAD: Once the site of an outdoor resort; Klahanie is an Indian word for "a good time outdoors."

LANDERS ROAD: Ephraim Landers settled above Cross Landing in 1882. This road was designated Ephraim Landers Road when it was built in 1901.

LISABEULA ROAD: Supposedly this name is derived from the names of two girls, Eliza and Beulah, working in the office to which John Brink applied for a post office permit. Howard Lynn gives the source as the postmaster's daughters' names.

LUANA BEACH ROAD: Frank Hubbell bought a tract on Maury's east shore in 1908, named it after two former girl friends, and established a summer resort which thrived until the late 1920's.

LUANA LANE: A short road parallel to Luana Beach Road, through the old Luana Resort property.

MADRONA ROAD: Goes to the Madrona West development.

. .

· ...

MANZANITA BEACH ROAD: Named in 1892 as part of the Tacoma Yacht Club Park plat. "Manzanita" is one name by which madrone or madrona is known in the Pacific Northwest.

MAURY PARK ROAD: William Maury was a member of the Wilkes survey party here in 1841.

McLEAN ROAD: John E. McLean was a pioneer and one of two partners who established the first store. McLean Road passes through the McLean homestead.

McCORMICK PLACE: Phillip McCormick came to Vashon in 1894. George McCormick operated a currant farm in the early part of the century.

McINTYRE ROAD: Established during the early part of the century, this is a short section of "old road" parallel to Westside Highway at the end of Cove Road.

MELCHERT WAY: The "old" name of this road is being made official by request of the residents.

MONUMENT ROAD: A monument dedicated to the pioneers was set at the junction of this road and Quartermaster Drive in 1927.

NORTHILLA ROAD: Northilla Beach was platted for summer homes in 1909 by the Norton-Hill Company of Tacoma.

NORTHILLA TRAIL: To the walk-ins southeast of Northilla Road.

OBER BEACH ROAD: Named in honor of John Ober, a postmaster and well-liked member of the community.

OLD HIGHWAY: This is the last remaining portion of the first concrete highway on Vashon.

OLD MILL ROAD: Called Mill Road since the 1920s when the Pankrantz Lumber Mill was located there.

OLYMPIC DRIVE: This road is located at the north end of the road once called Olympic View, now being designated as the Westside Highway.

PAIGE LANE: Jedediah Paige owned Cove waterfront property and kept a float anchored for steamboats from the 1880s to the turn of the century.

PALISADES AVENUE: Patten's Palisades was developed in 1957 by John Patten.

PATTEN LANE: Part of Patten's Palisades.

PILLSBURY ROAD: Charles Adams Pillsbury and his wife, Florence, moved to Harbor Heights, Vashon, in 1932.

POHL ROAD: Fred Pohl was an early landowner, circa 1901.

POINT PINER ROAD: Thomas Piner was a quartermaster on the Wilkes Expedition in 1841.

POINT ROBINSON ROAD: Point Robinson is the site of Vashon's lighthouse, built around 1890.

POINT VASHON DRIVE: Vashon Point was named by Wilkes during the expedition in 1841.

PORTAGE WAY: Portage is the causeway connecting Vashon and Maury, and overlooks Tramp Harbor. It was shored up and filled in 1916.

QUARTERMASTER DRIVE: The name Quartermaster was given to the first post office established on the harbor in 1890 on this road above the beach. Named for the quartermasters of the Wilkes Expedition.

RAYMOND ROAD: Requested by residents, in honor of the first family to live there -- Harold J. and Theresa Dell Raymond.

REDDINGS BEACH ROAD: The Redding family arrived in 1884 and at one time owned considerable acreage along the west shore of Vashon.

Captain Tom Redding ran boats between Vashon and the mainland for many years.

RIDGE ROAD: This road runs along the Klahanie ridge.

ROBINWOOD ROAD: Established in 1935 to provide access to the Robinwood Beach tract.

SANDY SHORES DRIVE: Sandy Shores was platted in 1965.

SEA BREEZE AVENUE: Provides access to Sea Breeze Farm Estates plat.

SHANAHAN ROAD: Mr. Shanahan owned and operated a popular lodge during the early part of the century.

SHAWNEE ROAD: Millard F. Shaw subdivided his land around 1907 and called his development "Shawnee."

SINGER ROAD: Named for Karl Singer.

SOPER ROAD: Timothy O. and Caroline Soper owned 40 acres in that area during the early part of the century.

SPRING BEACH ROAD: Named for springs at the beach.

STUCKEY AVENUE: A.J. Stuckey operated an extensive drydock business on Maury from the 1890s to the 1930s. He was also Dockton's Justice of the Peace from 1915 to 1920.

SUMMERHURST ROAD: Serves the area known as Summerhurst.

SUNSET ROAD: This road was built to provide access to Sunset Beach.

SYLVAN BEACH ROAD: This road which goes to Sylvan Beach was named by its builder during the early 1900s.

SYLVAN BEACH WALK: To the walk-ins along the beach north and south of Sylvan Beach Road.

TAHLEQUAH ROAD: An Oklahoma Indian word meaning "water view." Ethel
Whitfield of Burton submitted the name for the new south-end
ferry dock in 1920 and won a \$50 prize.

THORSEN ROAD: Thomas and Ole Thorsen were pioneers and early farmers.

TILLICUM LANE: A Chinook Indian word meaning "people" or "friend," this is the "old" name of this road.

TRAMP HARBOR ROAD: Originally Trump Harbor. There are two possibilities regarding the name source: (1) P.B. Van Trump, who with Hazard Stevens climbed Mount Rainier in 1870, or (2) Commander Von Trump of a geodetic survey boat

stationed there, circa 1850-1880.

VAN OLINDA ROAD: Oliver Scott Van Olinda, pioneer, published the first island

magazine, later the first (island) newspaper; taught at Burton College; operated a store; and wrote the first and

official history of Vashon-Maury Islands.

VASHON HIGHWAY: From the north end ferry dock to the south end ferry dock of

Vashon Island, named in honor of Admiral James Vashon.

VERMONTVILLE ROAD: This road lies in an area called Vermontville by early

settlers, who named it after their home state.

WAX ORCHARD ROAD: August Wax converted a 140-acre stump farm into fruit

orchards during the 1930s, and it still operates today.

WESLEYAN WAY: This road serves the Wesleyan community on Vashon Island. Name

WESTSIDE HIGHWAY: Originally called Olympic View by locals, later broken into

several numbered streets, it is being re-united now as the

Westside Highway, curving along the west side of the

island.

WINDMILL STREET: At one time there were windmills at both ends of this

street.
