ORDINANCE NO. **9172**

AN ORDINANCE cancelling Community Development Block Grant (CDBG) funding for Timberlane (Jenkins Creek) Park, and increasing CDBG funding for Springwood Park; also cancelling \$97,000 in funding for the Swamp Creek Acquisition Project and appropriating the same amount to a new project, the Ballinger Way Open Space Acquisition; and appropriation \$150,000 to a new project, the Lake Wilderness Inholding Acquisition; and amending Ordinance No. 8802, Sections 75 and 92, as amended.

PREAMBLE:

It has been determined that Timberlane Park, also known as Jenkins Creek Park, no longer meets the federal requirements for CDBG funding. It is therefore necessary to reallocate the remaining funds to Springwood Park, which is CDBG-eligible. Concurrent with this action, Parks, Recreation and Open Space Fund No. 316 will be adjusted administratively, transferring Current Expense funds from Springwood Park to Timberlane (Jenkins Creek) Park, thus leaving both parks with no change in the total dollar amounts programmed for them.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a revenue exchange between Timberlane Park and Springwood Park cancelling \$51,078 in CDBG funding from Timberlane Park and appropriating it to Springwood Park; a cancellation of \$97,000 from Swamp Creek Acquisition Project 316175 and an appropriation of \$97,000 to a new Ballinger Way Open Space Acquisition CIP Project; and an appropriation of \$150,000 to a new Lake Wilderness Inholding Acquisition CIP Project from Fund 316 fund balance.

SECTION 2. Ordinance No. 8802, Section 75, as amended, is hereby amended by adding thereto and inserting therein the following:

C85723 Timberlane Park - (\$51,073)

C89185 Springwood Public Housing Play Equipment/Ballfields \$51,073

SECTION 3. Ordinance No. 8802, Section 92, Attachment 2, as amended, is hereby amended by adding thereto and inserting therein the following:

Swamp Creek Park Acquisition (\$97,000)


Ballinger-Way Open Space Acquisition \$97,000

Lake Wilderness Inholding Acquisition \$150,000
