AN ORDINANCE relating to the annexation of an area known as 308 S to Soos Creek Water and Sewer District, for sewer service.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as 308 S to Soos Creek Water and Sewer District was filed with the county council effective September 14, 1989.

2. Soos Creek Water and Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 0347-S concurred with the proposed annexation for sewer service.

3. Soos Creek Water and Sewer District filed a Declaration of Non-significant Impact dated April 6, 1989, on the proposed annexation.

4. The county council held a public hearing on the 23rd day of OCTOBER, 19 89 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Soos Creek Water and Sewer District of the area known as 308 S and described in Section 4 herein is approved for sewer service. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on 308 S.

SECTION 2. The Soos Creek Water and Sewer District is the appropriate entity to serve the area proposed to be annexed for sewer service.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

SECTION 4. The area known as 308 S to be annexed for sewer service is described as follows:

Beginning at the Southeast corner of the Southwest quarter of Section 29, Township 22 North, Range 6 East, W.M., in King County, Washington, said point lies on the existing boundary of Soos creek Water and Sewer District;

Thence Westerly along the South line of said Section to the West line of the East half of the West half of the Southeast quarter of the Southwest quarter of said section 29;

Thence Northerly along the West line of said East half of the West half, to the South line of the Northeast quarter of the Southwest quarter of said section 29;

Thence Westerly along the South line of said subdivision to the Southwest corner of said Northeast quarter of said Southwest quarter of said section 29;

Thence Northerly along the North-South centerlines of said Southwest quarter and the Northwest quarter of said Section to the North line of the Southeast quarter of the Northwest quarter of said Section 29;

Thence Easterly along said North line of said Southeast quarter of the Northwest quarter to the East line of the West half of said Section 29;

Thence Southerly along said East line to the Southeast corner of said West half of said Section 29, and the Point of Beginning.

INTRODUCED AND READ for the first time this 25th day of September, 1989.
