- 1. A petition has been filed requesting vacation of a portion of South 324th Street, hereinafter described.
- 2. The department of public works has notified the various utilities serving the area and has been advised that easements have been granted to Puget Power, U.S. West Telephone Company, Federal Way Water District and the City of Auburn.
- 3. The building and land development division has reconsidered the previously denied petition for vacation of a portion of South 324th Street and finds that it would not be in conflict with the principles and purposes of the King County Comprehensive Plan and the specific plans in the vicinity of this proposed vacation.
- 4. The department of public works found no evidence that the vacation area has ever been opened as a road. A search of the records indicates that no public funds have been expended for its acquisition, improvement or maintenance.
