ORDINANCE NO. AN ORDINANCE relating to the annexation of an area known as 89-6 to Rainier Vista Sewer

STATEMENT OF FACT:

District.

- 1. A notice of intention proposing the annexation of an area known as 89-6 to Rainier Vista Sewer District was filed with the county council effective November 28, 1989.
- Rainier Vista Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 572 concurred with the proposed annexation.
- Rainier Vista Sewer District filed a Declaration of Non-significant Impact dated June 12, 1989, on the proposed annexation.
- The county council held a public hearing on the 29th day January, 19 90 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Rainier Vista Sewer District of the area known as 89-6 and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on 89-6.

SECTION 2. The Rainier Vista Sewer District is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

All that portion of the South half of section 8 and the North half of Section 17,m all in Township 23 North, Range 4 East, W.M., described as follows:

BEGINNING on the Easterly margin of SR-509 (SSH No. 1-K) 230 feet North of the South line of the Southwest quarter of Section 8, being on the North line of Lot 13, Block 13, Cedarhurst Division No. 3 Unrecorded;
