ORDINANCE NO. **9312**

AN ORDINANCE relating to the annexation of an area known as 306 S to Soos Creek Water and Sewer District for sewer service.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as 306-S to Soos Creek Water and Sewer District for sewer service was filed with the county council effective December 14, 1989.

2. Soos Creek Water and Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 0404-S concurred with the proposed annexation for sewer service.

3. Soos Creek Water and Sewer District filed a Declaration of Non-significant Impact dated October 5, 1989, on the proposed annexation.

4. The county council held a public hearing on the 8th day of JANUARY, 19 90 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Soos Creek Water and Sewer District for sewer service of the area known as 306 S and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on 306 S.

SECTION 2. The Soos Creek Water and Sewer District is the appropriate entity to serve the area proposed to be annexed for sewer service .

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this

1 annexation area, nor does it authorize sewer service in any area
2 not designated as a "Local Service Area" by the King County
3 Sewerage General Plan.

4 SECTION 4. The area known as 306 S to be annexed is described
5 as follows:

7 Beginning at the intersection of the North line of the South
8 135.00 feet of the Northwest quarter of the Southwest quarter
9 of Section 21, Township 22 North, Range 6 East, W.M., in King
10 County, Washington and the West line of the Northeast quarter
11 of the Southwest quarter of said Section 21, said point being
12 on the existing Soos Creek Water and Sewer District boundary;

13 Thence Northerly along said West line to the North line of the
14 Southwest quarter of said Section 21;

15 Thence Easterly along said North line to the North-South
16 centerline of said Section 21 also being the centerline of
17 Witte Road S.E.;

18 Thence Southerly and Southwesterly along said centerline of
19 Witte Road S.E. to its intersection with the South line of
20 said Northeast quarter of the Southwest quarter of said
21 Section 21;

22 Thence Westerly along said South line to the West line of said
23 Northeast quarter of the Southwest quarter of said Section 21;

24 Thence Northerly along said West line to the Point of
25 beginning.
