ORDINANCE NO. **9331**

AN ORDINANCE making a supplemental appropriation of \$34,000 to CIP Project No. 662048, Work Release Remodel, in the Jail Renovation and Construction Fund and a supplemental appropriation of \$16,000 to the department of adult detention, to construct office space for work release case managers in the remodeled courthouse work release facility, and \$34,000 to Capital Project Transfers from the unappropriated Current Expense Fund balance; amending Ordinance 8802, Sections 42, 50, and 92, Attachment 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a supplemental appropriation of \$34,000 to CIP Project No. 662048, Work Release Remodel, in the Jail Renovation and Construction Fund and a supplemental appropriation of \$16,000 to the department of adult detention, to construct office space for work release case managers in the remodeled courthouse work release facility and \$34,000 to Capital Project Transfers from the unappropriated Current Expense Fund Balance.

SECTION 2. Ordinance No. 8802, Section 42, as amended, is hereby amended by adding thereto and inserting therein the following:
