ORDINANCE NO.

AN ORDINANCE relating to the district court of King County, correcting the election status of district court judges; amending Ordinance 8935, Section 4 and K.C.C. 2.68.070.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 8935, Section 4 and K.C.C. 2.68.070 are hereby amended to read as follows:

King County District Court Organization.

- A. NAME AND BOUNDARIES OF THE COURT: There shall be a single district court with boundaries of all the area within the boundaries of King County which include to the centerline of Puget Sound and all of the current city of Bothell as a joint district court district established pursuant to R.C.W. 3.38.060 and named the District Court of the State of Washington in and for the district of King County.
- B. NUMBER OF JUDGES TO BE ELECTED: Twenty-four full time judges ((elected_at_large.))
 - C. POPULATION: 1,413,900.
- D. LOCATION OF CENTRAL OFFICE: King County Courthouse, Seattle, Washington.
- E. LOCATION OF COURTROOMS: There are ten court facilities within the unified district located as follows:
 - 1. Aukeen, located within the City of Kent.
 - 2. Bellevue.
 - 3. Federal Way.
 - 4. Issaquah.
 - 5. Mercer Island.
 - 6. Northeast, located within the City of Redmond.
 - 7. Renton.
 - 8. Seattle.
 - 9. Shoreline, located within the Shoreline community planning area.
- 10. Southwest, located in the vicinity of Burien with additional facilities in the vicinity of the Vashon business district.
- F. LOCATION OF RECORDS: EAdministrative records shall be maintained at the central office or as designated by the presiding judge. Court records shall be
