ORDINANCE NO. **9413**

AN ORDINANCE relating to paid parking in county owned parking facilities; and amending Ordinance No. 8753, Section 5 and 6, as amended; and K.C.C. 3.32.045 and K.C.C. 3.32.055, and Ordinance No. 3511, Section 3 as amended K.C.C. 3.32.020, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 8753, Section 5, as amended and K.C.C. 3.32.055 are amended to read as follows:

Parking Rates - Parking Stalls. Parking rates - parking stalls in the King County automotive center, adult detention center ((and)), courthouse and open surface parking lots. The basic monthly parking rate for these parking stalls ~~((in the county automotive center, adult detention center, and courthouse))~~ shall be as follows:

Effective Date	Covered Parking	((Uncovered Parking)) <u>Surface Lots</u>
((January 1, 1989))	((\$55.00))	((\$50.00))
April 1, 1990	\$65.00	\$60.00

PROVIDED THAT: for disabled county employees whose disabilities make it difficult or impossible to use public transit, and who display a disabled parking permit, the fee for Covered Parking shall be 50 percent of the normal rate.

SECTION 2. Ordinance No. 3511, Section 3, as amended, and K.C.C. 3.32.020 are amended to read as follows:

Parking Fees - General. A. All county employees and elected officials who are assigned the regular use of a parking stall, or who are authorized the use of available unassigned parking stalls on a regular basis while engaged in county business, within any of the county-owned parking facilities, shall pay parking fees as provided in this chapter. Parking fees shall not be paid by the county ~~((in))~~ on behalf of any individual employee or elected

1 official who is assigned the regular use of a county parking stall
2 regardless of whose vehicle that person parks in the stall.
3 Current((ly)) county employees covered by existing collective
4 bargaining agreements shall be affected only in a manner
5 consistent with state law.

6 Any exemptions to garage parking fees are subject to approval
7 by council motion. A list of county employees recommended for
8 exemption and the reason for their exemption should be presented
9 annually by January 31st to the council for approval before
10 exemptions are granted.

11 B. Method of payment. Such parking fees shall be paid
12 through monthly payroll deductions from the wages of the employee
13 or elected official who is assigned the regular use of the county
14 parking stall regardless of whether that person is assigned the
15 use of a county-owned vehicle, assigned a vehicle provided at
16 county expense, or uses a privately-owned vehicle.

17 C. Optional survey. The department of executive
18 administration may conduct a survey of the monthly parking rates
19 charged for public parking in lots of ten or more spaces within
20 the area bounded by Jackson Street on the south, Sixth Avenue on
21 the east, Columbia Street on the north and Second Avenue on the
22 west. Such survey and any parking fee recommendations shall be
23 forwarded to the council for consideration during the budget
24 process.

25 SECTION 3. Ordinance No. 8753, Section 6, as amended, and
26 K.C.C. 3.32.045 are amended to read as follows:

27 Parking rates - surface parking lots. The parking rates for

A. Daily general parking on county business which exceeds the two hour limit, general public parking not on county business, and county employees not assigned regular parking stalls:

1. Effective April 1, 1989:

0 - 2 hours	\$3.00
2 - 4 hours	\$5.00
4 -10 hours	\$7.00
Special events	\$6.00

PROVIDED THAT:

No county employees not permanently assigned to a downtown work station shall pay more than \$60.00 in any calendar month for such unassigned parking.

2. Evenings after 6 p.m.. and all day Saturday, Sunday and legal holidays except during special events \$4.00.

~~((Effective-January-1,-1989-\$50.00-per-month))~~

~~((G-)) B. Special events rates - conditions. Special events rates shall apply after 6 p.m. weekdays and all day Saturday, Sunday and legal holidays and shall apply during those events designated in accordance with Section 3.32.010. ((These-rates-shall-not-apply-to-county-employees-using-county-parking-stalls~~

~~while-engaged-in-county-business-))~~ Parking for special events shall be provided in surface lots and in the county automotive center, provided that county employees who pay for parking privileges in the automotive center shall be exempted from payment of the special event fee.

SECTION 4. The county council finds as a fact and declares that an emergency exists and that this ordinance is necessary for the immediate preservation of public peace, health or safety or for the support of county government and its existing public institutions.

INTRODUCED AND READ for the first time this 26th day of February, 1990.
