ORDINANCE NO. **9429**

AN ORDINANCE making a supplemental appropriation of \$8,538 to the Public Health Pooling Fund from Current Expense Special Programs - Executive Contingency; \$11,455 to Emergency Medical Services Fund from the unappropriated Emergency Medical Services Fund balance; and \$18,319 to the Public Health Pooling Fund from the unappropriated Public Health Pooling Fund balance and interlocal payments; amending Ordinance 9221, Sections 37, 40, 70 and 71, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There are hereby approved and adopted supplemental appropriations of \$8,538 to the Public Health Pooling Fund from Special Programs - Executive Contingency; \$11,455 to Emergency Medical Services Fund from the unappropriated Emergency Medical Fund balance; and \$18,319 to the Public Health Pooling Fund from the unappropriated Public Health Pooling Fund balance and interlocal payments.

SECTION 2. Ordinance No. 9221, Section 37, as amended, is hereby amended by adding thereto and inserting therein the following:
