AN ORDINANCE approving the 1990 1% for Arts Project Plan, establishing new projects for Art, and appropriating funds to Art projects; amending Ordinance 9221, Section 19; Section 92, Attachments No. 1 and 2; and Section 93, Attachment 3, as amended.
