AN ORDINANCE making a supplemental appropriation of \$87,506 from unencumbered fund balance to the Airport Fund (Fund 429) for transfer of \$62,506 to the Airport Fund No. 338, to pay for development of Hangar #1, second floor offices, CIP Project No. 001298, and for payment of the county's \$25,000 share of the cost of a feasibility study to consolidate the King County Airport with the Port of Seattle; and amending Ordinance 9221, Sections 78 and 92, Attachments No. 1 and No. 2, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$87,506 from unencumbered fund balance to the Airport Fund for the county's \$25,000 share of the cost of a feasibility study to consolidate the King County Airport with the Port of Seattle, and \$62,506 for transfer to the Airport Construction Fund No. 338, to pay for development of Hangar #1, second floor offices, CIP Project No. 001298.

SECTION 2. There is hereby approved and adopted an appropriation of \$62,506 from the Airport Fund (Fund 429) to the Airport Construction Fund.

SECTION 3. Ordinance 9221, Section 78, as amended, is hereby amended by adding thereto and inserting therein the following:

AIRPORT - From the Airport Fund there is hereby appropriated to:

Provided That: The \$25,000 for the feasibility study of consolidating the King County Airport with the Port of Seattle will not be disbursed until the Council has authorized an interlocal agreement and scope of work for this purpose.

SECTION 4. Ordinance No. 9221, Section 92, Attachments No. 1 and No. 2 as amended, is hereby amended by adding thereto and inserting therein the following:
