

ORDINANCE NO. **9595**

AN ORDINANCE relating to fees charged for the use of King County parks and recreation facilities and amending Ordinance No. 5225, Section 2(A), as amended, and K.C.C. 7.08.020, Ordinance 9227, Section 2, and K.C.C. 7.08.025.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 5225, Section 2(A), as amended, and K.C.C. 7.08.020 are amended to read as follows:

I. Swimming pool facilities (except King County Aquatics Center). Swimming pool facilities fees shall be:

A. Swimming pool fees (fees include sales tax)

Public Swims:.....(~~\$1.00~~) \$1.20 per person per session

(~~Fifty~~) Sixty Cent Swims:.....(~~.50~~) .60 per person per session

Adult Only Swims:(~~1.50~~) 1.80 per person per session

Senior citizens-60 years plus.....(~~1.00~~) 1.20 per person for any

program session.

B. Swim lessons: \$1.00 per half hour to \$10.00 per half hour

C. Pool rentals

1. Private rentals

25 persons or less.....(~~\$27.50~~) \$32.45 per hour

26 - 60 persons.....(~~37.50~~) 44.25 per hour

61 - 90 persons.....(~~50.00~~) 59.00 per hour

91 - 120 persons.....(~~60.00~~) 70.80 per hour

121 - 150 persons.....(~~75.00~~) 88.50 per hour

2. Special interest groups.....(~~21.50~~) 25.50 per hour

3. School districts.....(~~15.00~~) 17.70 per hour

4. King County Park Swim Teams

When sharing the pool..... (~~12.00~~) 14.15 per hour

When using the entire pool....(~~18.00~~) 21.25 per hour

D. Family membership program (Entitles member to all public swims and adults to all adult swims, including the Recreation Pool in the King County Aquatic Center.)

1. Three Months

Youth 17 years or younger.....(~~\$32.50~~) \$38.35 plus sales tax

1 Adult, 18 years or older.....((54.00)) 63.75 plus sales tax
2 Family, 2 or more.....((78.00)) 92.00 plus sales tax
3 Senior citizens, 60 years or older.((32.50)) 38.35 plus sales tax

4 2. Yearly

5 Youth, 17 years or younger....((\$ 85.00)) \$100.30 plus sales tax
6 Adult, 18 years or older..... ((140.00)) 165.20 plus sales tax
7 Family, 2 or more.....((208.00)) 239.20 plus sales tax
8 Senior citizens, 60 years or older.((65.00)) 76.70 plus sales tax

9 E. Locker Fees..... \$ 0.25 per locker

10 F. Individuals with physical or developmental disabilities shall receive
11 the same rate as senior citizens.

12 G. Individuals with physical or developmental disabilities shall provide
13 documented proof of disability to qualify for reduced fees.

14 SECTION 2. Ordinance No. 9227, Section 2 and K.C.C. 7.08.025 is hereby
15 amended to read as follows:
