AN ORDINANCE adding 1 FTE to the Employee Assistance Program, authorizing the use of previously appropriated contract funds to pay salary and benefits, and amending Ordinance 9221, Section 25, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 9221, Section 25, as amended, is hereby amended by adding thereto and inserting therein the following:

PERSONNEL - From the Current Expense Fund there is hereby appropriated to:

Personnel

The maximum number of additional FTEs for Personnel shall be increased by:

1.00

Provided that:

The 1990 adopted budget includes \$54,350 and 1 FTE Disability Coordinator for the purposes of improving the county's capacity to return injured workers to the county workforce and recruiting and placing disabled persons in appropriate county jobs.

Provided further that:

By March 31, 1990, the executive shall submit for council review and approval a personnel division management plan which includes the following elements:

- 1. A purpose statement for the division;
- 2. An organization chart reflecting the positions and functions authorized in the 1990 adopted budget, along with a description of the responsibilities of each functional unit;
- 3. A plan for improved coordination between personnel staff in operating departments and personnel staff in the division; and
- 4. A proposal describing how the division's resources will be used to address key operational problem areas, including labor
