BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a supplemental appropriation of \$207,445 to the office of finance, of \$6,840 to the real property division, and of \$7,215 to the facilities management division from special programs - executive contingency; and a supplemental appropriation of \$12,460 (2.3 analyst months or .2 FTE) to the systems services division from the systems services operating fund balance; for the integrated fixed assets accounting system.
