ORDINANCE NO.

AN ORDINANCE relating to the annexation of an area known as No. 36 School to Cedar River Water and Sewer District for water service.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area known as No. 36 School to Cedar River Water and Sewer District for water service was filed with the county council effective October 1, 1990.
- 2. Cedar River Water and Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 2767 concurred with the proposed annexation for water service.
- 3. Cedar River Water and Sewer District filed a Declaration of Non-significant Impact dated June 29, 1990, on the proposed annexation.
- 4. The county council held a public hearing on the 2rd day of January, 19 9/ and has considered the criteria set forth in R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Cedar River Water and Sewer District of the area known as No. 36 School and described in Section 4 herein is approved for water service. This proposed annexation is consistent with R.C.W. 57.02.040 as described in the attached King County Council Annexation Report on No. 36 School.

SECTION 2. Cedar River Water and Sewer District is the appropriate entity to serve the area proposed to be annexed for water service.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits,

certifications, or actions necessary to provide service to this 2 annexation area. 3 SECTION 4.
