## ordinance no. 9793

AN ORDINANCE dissolving King County Road Improvement District No. 115 created for the purposes of converting overhead utilities to underground in the Redondo vicinity.

## PREAMBLE:

Pursuant to King County Motion No. <u>O(2)</u>, a public hearing was held on <u>January 22</u>, 1991, to dissolve RID No. 115 created to convert existing overhead electric and communications facilities to underground facilities along certain streets. Notice of said hearing was duly published and was duly mailed to each property owner in the manner set forth in RCW 36.88.050 for establishment of a road improvement district. All written and verbal protests were considered. It is further found that all notice requirements of King County Motion No. <u>O(2)</u> have been satisfied.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby dissolved a road improvement district in King County known and designated as "King County Road Improvement District No. 115" (hereinafter "RID No. 115"). Said District includes all the territory described as follows:

Beginning at a meander corner located north 2037.92 feet from the west quarter corner Section 5, Township 21 north, Range 4 east, W.M.; thence northeasterly along the westerly right-of-way margin of Redondo Beach Road to a point of intersection with the centerline of South 287th Street; thence southeasterly along said centerline 320 feet; thence southwesterly 30 feet to the southeast corner of lot 16 block 3 Redondo Beach Division No. 1: thence southwesterly to the southwest corner of lot 17 block 3; thence southeasterly to the northeast corner of lot 3 block 3; thence southwesterly along the southeasterly boundary of that portion vacated by King County Ordinance 7473 to the southeasterly margin of right-ofway of Fifth Place South; thence westerly to the southwest corner of lot 3 block 2 Redondo Beach Division No. 1; thence westerly along the southeasterly boundary of block 2 to a point of intersection with the westerly boundary of Redondo Beach Division No. 1; thence N 13° 41' 30" W along said western boundary to a point on the

boundary line 148.60 feet south of the intersection of said boundary and the centerline of Redondo Beach Road; thence S 57° 16' 54" W 266 feet more or less to the north line of said section 5; thence S 89° 31' 38" W along said section line 149.43 feet more or less to the northeast corner of lot 16 plat of Del Ray Park unrecorded; thence southwesterly along the southeasterly boundary of lots 16 and 15 to the easterly margin of Del Ray Park Drive; thence southerly and northerly along said margin to the southeast corner of lot 5 Del Ray Park; thence southwesterly along the south boundary of said lot 5 to the easterly margin of right-of-way of First Avenue South; thence northerly to the point of beginning.

SECTION 2. The director of the department of public works is hereby authorized and directed to tabulate costs and expenses for preliminary engineering and administration in conjunction with the work done to date on RID 115. Said director is further authorized and directed to recover the costs and expenses of RID No. 115 from any road improvement district created in the future for the purposes of converting overhead electric and communication facilities to underground facilities, to the extent such costs and expenses are for work which benefits such later improvement.

SECTION 3. The department of public works, roads division is hereby authorized and directed to transfer \$3,884 from the road improvement dis-

trict guaranty fund to reimburse road fund expenditures for engineering and administration on the project. INTRODUCED AND READ for the first time this 16th day of July 19<u>90</u>.
