

ORDINANCE NO. **9852**

AN ORDINANCE appropriating \$816,396 to various divisions within the public works department to pay for additional costs related to labor contract and settlement increasing the work day, and supervisory and salary adjustments, amending Ordinance 9221, Sections 55, 57, 59, 77, and 78 as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$816,396 to various divisions within the public works department: \$481,876 to the County Road Fund (Fund 1030); \$242,710 to the Surface Water Management Fund (Fund 1210); \$25,190 to the River Improvement Fund (Fund 1050); \$46,466 to the Solid Waste Fund (Fund 4040); and \$20,154 to the Airport Fund (Fund 4290); from various division unencumbered fund balances; to pay for additional costs related to the International Federation of Professional and Technical Engineers local 17 labor contract settlement increasing the work day from seven to eight hours (Ordinance 9245) and arbitrated supervisory engineer retroactive pay and salary adjustments (Ordinance 9659).

SECTION 2. Ordinance 9221, Section 55, as amended, is hereby amended by adding thereto and inserting therein the following:
