

ORDINANCE NO. **9875**

AN ORDINANCE appropriating \$1,466,198 to several agencies for costs associated with preparing the Yesler Building for occupancy, and amending Ordinance 9720, Sections 26, 58, 61, 62, and 78, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$1,466,198 to several agencies as follows: \$52,140 from the Current Expense Fund to the Facilities Division; \$222,705 from the Roads Fund to Public Works Administration; \$34,179 from the River Improvement Fund to River Improvements, \$323,587 from the Surface Water Management Fund to the Surface Water Management Division, and \$833,587 from the Solid Waste Management Fund to prepare the Yesler Building for occupancy: remodeling, relocating, and providing furnishings and security.

SECTION 2. Ordinance 9720, Section 26, as amended, is hereby amended by adding thereto and inserting therein the following:

FACILITIES MANAGEMENT - From the Current Expense Fund there is hereby appropriated to:

Facilities Management \$52,140

SECTION 3. Ordinance 9720, Section 58, as amended, is hereby amended by adding thereto and inserting therein the following:

PUBLIC WORKS ADMINISTRATION - From the Roads Fund there is hereby appropriated to:

Public Works Administration \$222,705

SECTION 4. Ordinance 9720, Section 61, as amended, is hereby amended by adding thereto and inserting therein the following:

RIVER IMPROVEMENTS - From the River Improvement Fund there is hereby appropriated to:

River Improvements \$ 34,179

SECTION 5. Ordinance 9720, Section 62, as amended, is hereby amended by adding thereto and inserting therein the following:

SURFACE WATER MANAGEMENT - From the Surface Water Management Fund there is
