There is hereby approved and adopted an appropriation of \$100,000 of unencumbered Real Estate Excise Tax (REET) Fund balance to the Real Estate Excise Tax Fund to replace Current Expense Funds in the same amount currently programmed in the Parks Capital Improvement Program; disappropriating \$100,000 from Capital Project Transfers - CX to be reprogrammed from the Parks Capital Improvement Program to the Parks Division; and this appropriation of \$100,000 to the Parks Division is to initiate a comprehensive parks, recreation and open space plan.

REAL ESTATE EXCISE TAX (REET) FUND - From the REET Fund there is hereby appropriated to:

Real Estate Excise Tax Fund
