ORDINANCE NO. 9996

AN ORDINANCE revising the voting precincts of King County for the year 1991, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Pursuant to K.C.C. 1.12.010E, the attached revision to the King County voting precincts is hereby adopted and shall amend the official list of county voting precincts which are maintained by the records and elections division.

SECTION 2. The county council finds as a fact and declares that an emergency exists and that this ordinance is necessary for the immediate preservation of public peace, health or safety or for the support of county government and its existing public institution.
