AN ORDINANCE appropriating \$365,990 to the department of adult detention and \$47,915 to the facilities management division, from special programs - executive contingency, and \$21,600 to systems services - data processing from additional revenues to fulfill requirements of stipulated orders relating to the settlement of the Hammer et al. v. King County lawsuit; and amending Ordinance No. 9720, Sections 26, 36, 42, and 86, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There are hereby approved and adopted appropriations of \$365,990 to the department of adult detention and \$47,915 to the facilities management division, from special programs - executive contingency, and \$21,600 to systems services - data processing from additional revenues to fulfill requirements of stipulated orders relating to the settlement of the Hammer et al. v. King County lawsuit.

SECTION 2. Ordinance No. 9720, Section 26, as amended, is hereby amended by adding thereto and inserting therein the following:

FACILITIES MANAGEMENT - From the Current Expense Fund there is hereby appropriated to:

Facilities Management \$47,915

SECTION 3. Ordinance 9720, Section 36, as amended, is hereby amended by adding thereto and inserting therein the following:

SPECIAL PROGRAMS - EXECUTIVE CONTINGENCY - From the Current Expense Fund there is hereby disappropriated from:

Special Programs - Executive Contingency (\$413,905)

SECTION 4. Ordinance No. 9720, Section 42, as amended, is hereby amended by adding thereto and inserting therein the following:

ADULT DETENTION - From the current expense fund there is hereby appropriated to:

Adult Detention \$365,990

1 The maximum number of additional FTEs for adult detention  
2 shall be: 4.8
