AN ORDINANCE making an appropriation of \$850,721 to the Harborview Repair and Replacement Fund from depreciation reserves, amending Ordinance No. 9720, Section 94, Attachment 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$119,200 to CIP No. 678283 in Fund 396, Harborview Repair and Replacement Fund from the depreciation reserves for Harborview asbestos abatement needs.

SECTION 2. There is hereby approved and adopted an appropriation of \$516,521 to CIP No. 678272 in Fund 396, Harborview Repair and Replacement Fund from the depreciation reserves for Harborview miscellaneous under \$50,000 needs.

SECTION 3. There is hereby approved and adopted an appropriation of \$150,000 to CIP No. 678273 in Fund 396, Harborview Repair and Replacement Fund from the depreciation reserves for Harborview Architectural and Engineering Fees needs.

PROVIDED that Harborview Medical Center develop a comprehensive equipment needs assessment plan which prioritizes equipment requests and develops a schedule for their purchase and installation. Equipment costs shall be estimated and include the costs associated with installation. This plan shall then become the basis for evaluating all future appropriation requests for fixed equipment or fixed equipment installation.

SECTION 4. There is hereby approved and adopted a new project appropriation of \$65,000 to CIP No. 678300 in Fund 396, Harborview Repair and Replacement Fund from the depreciation reserves for Harborview Architectural and Engineering Fees needs.

1 PROVIDED that the administration of the project supported
2 by this appropriation be exempt from the provisions of K.C.C.
3 Title 4, notwithstanding K.C.C. 2.42.080 E.

4 SECTION 5. Ordinance 9720, Section 94, as amended, is
5 hereby amended by adding thereto and inserting therein the
6 following:
