ORDINANCE NO. 10095

AN ORDINANCE relating to the annexation of an area known as 322-S to Soos Creek Water and Sewer District for sewer service.

## STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of an area for sewer service known as 322-S to Soos Creek Water and Sewer District was filed with the county council effective August 7, 1991.
- Soos Creek Water and Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 0653-S concurred with the proposed annexation.
- Soos Creek Water and Sewer District filed a Declaration of Non-significant Impact dated March 28, 1991, on the proposed annexation.
- The county council held a public hearing on the 3rd day of September, 199/ and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Soos Creek Water and Sewer District of the area known as 322-S and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on 322-S.

The Soos Creek Water and Sewer District is the SECTION 2. appropriate entity to serve the area proposed to be annexed.

Completion of this annexation does not SECTION 3. constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

The area known as 322-S to be annexed is SECTION 4. described as follows:

That portion of the Northeast one-quarter of the Southeast one-quarter of Section 16, Township 22 North, Range 6 East, W.M., King County, Washington, lying Northeasterly of the centerline of Southeast 231st Street (County Road #1183) and Northwesterly of the centerline of Witte Road Southeast (County Road 1055), less C/M Rights;


