

ORDINANCE NO. **10199**

AN ORDINANCE making an appropriation of \$124,220 to the Jail Renovation and Construction Fund, CIP Project No. 662048 - Work Release Remodel Project; and making an appropriation of \$141,852 to the Jail Renovation and Construction Fund, CIP Project No. D03880 - Jail Renovation Fund Default; and amending Ordinance No. 9720, Sections 94 and 95, Attachments 1 and 3, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$124,220 to the Jail Renovation and Construction Fund, CIP Project No. 662048 - Work Release Remodel Project, for the purpose of funding the increased cost of remodelling the work release office space and an appropriation of \$141,852 to the Jail Renovation and Construction Fund, CIP Project No. D03880 - Jail Renovation Fund Default, to support incurred interest charges.

SECTION 2. There is hereby approved and adopted an appropriation of \$124,220 to the Building Modernization and Construction Fund, CIP Project No. 666258 - Transfer to Fund 388, from unappropriated fund balance.

SECTION 3. Ordinance No. 9720, Section 94, as amended, is hereby amended by adding thereto and inserting therein the following:

CIP PROJECT APPROPRIATIONS - From the several capital improvement project funds there are hereby appropriated and authorized to be disbursed the following amounts.
