AN ORDINANCE relating to cable communications, granting the extension of a cable television franchise to Edmonds Cable Company.

## STATEMENT OF FACTS

- Edmonds Cable Company currently holds cable television franchise number 563 granted by King County. That franchise expired on February 13, 1992.
- County staff have discussed renewal of the franchise with the franchisee; however, no agreement has been reached.
- Edmonds Cable Company has requested that its franchise be extended.
- The county wants to extend the franchise to facilitate an orderly review of franchise renewals.
- The council has determined that it is in the best interest of the citizens of King County to grant the franchise extension listed below.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The council hereby grants Edmonds Cable Company an extension of franchise number 563 until June 18, 1992.

The extension is granted subject to the SECTION 2. condition that if within thirty (30) days of the council's passage of this ordinance Edmonds Cable Company fails to sign a franchise extension agreement in substantially the form contained in Exhibit A which is attached to and a part of this

## FRANCHISE EXTENSION AGREEMENT
