ORDINANCE NO.

AN ORDINANCE making an appropriation in the amount of \$1,409,048 to the roads and engineering division to provide for preliminary engineering and environmental impact statement activities for the projects known collectively as the Bear Creek Transportation Projects; and amending Ordinance No. 10182, Sections 59, 97 and Attachment 2, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. From reimbursement funds provided through contractual agreement by the Quadrant Corporation and Blakely Ridge Limited Partnership, there is hereby approved and adopted an appropriation of \$1,389,000 to the County Road Construction Fund to provide for preliminary engineering and environmental impact statement activities for CIP Project No. 100992, Novelty Hill Road (\$529,000); CIP Project No. 100392, 196th Avenue Northeast (\$210,000); CIP Project 100492, NE 133rd Street (\$325,000); CIP Project 100592, 236th/238th Avenue Northeast (\$325,000); and \$20,048 to the County Road Operating Fund to provide for operating costs associated with said projects.

SECTION 2. Ordinance No. 10182, Section 59, as amended is hereby amended by adding thereto and inserting therein the following:

ROADS OPERATING - From the County Road Fund there is hereby appropriated to:

Roads Operating \$20,048

The maximum number of additional FTEs for Roads Operating shall be: 3.0

SECTION 3. Ordinance No. 10182, Section 97, as amended, is hereby amended by adding thereto and inserting therein the following:

From the several capital improvement project funds there are hereby appropriated and authorized to be disbursed the following amounts for the specific projects identified in Attachment No. 2 of this ordinance.
