AN ORDINANCE amending the "King County Road Standards," 1986 update, establishing the maximum number of dwelling units served by a residential neighborhood collector street, amending Ordinance 8041, Section 2, and K.C.C. 14.42.010.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 8041, Section 2 and K.C.C. 14.42.010 are hereby amended to read as follows:

Adoption. A. "King County Road Standards," 1986 update, incorporated herein as Attachment A, including the changes identified in the errata sheets dated December 10, 1986 and December 17, 1986, are hereby approved and adopted as the King County standards for road design and construction.

- B. The department of public works is hereby authorized to revise and renumber the drawings in the King County Road Standards, 1986 update to comply with changes verbally described in the errata sheets.
- C. The department of public works is hereby authorized to incorporate drawings for catch basins and manholes provided by the Washington State Department of Transportation and the American Public Works Association into these standards after the date of adoption of this ordinance.
- D. The following text shall be incorporated as Chapter 2.19
 of the King County Road Standards, 1986 update:

Residential Access. For a residential subdivision, short subdivision, binding site plan, or planned unit development, no residential neighborhood collector street shall serve more than 100 lots or dwelling units unless said residential neighborhood collector street is connected in at least two locations with another public roadway that functions at a level consistent with Chapter 2.03.
