

ORDINANCE NO. **10509**

AN ORDINANCE relating to drug-free zones; approving a map of the location and boundaries of areas in the Lake Washington School District within which unlawful transactions in controlled substances are subject to enhanced penalties pursuant to RCW 69.50.435, and adding a new section to K.C.C. 12.82.

PREAMBLE:

Ordinance 10154 established a procedure for the production or reproduction of maps depicting the location and boundaries of parks, schools and areas within one thousand feet of schools, within which unlawful transactions in controlled substances are subject to enhanced penalties as imposed pursuant to RCW 69.50.435. Upon request of the governing body of the Lake Washington School District, King County has prepared a map depicting such boundaries. It is in the public interest to provide notice of the location of such areas and to expedite prosecution, conviction, and enhanced penalties for cases of unlawful transactions in controlled substances in such locations.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1: The boundaries of drug-free zones surrounding the following schools as listed in Exhibits "A" thru "N-2" located within the Lake Washington School District are hereby adopted:

- A. Louisa May Alcott Elementary School
- B-1 and B-2. Emily Dickinson Elementary and
Evergreen Junior High Schools
- C. Robert Frost Elementary School
- D. Christa McAuliffe Elementary School
- E. Margaret Mead Elementary School
- F. John Muir Elementary School
- G. Carl Sandburg Elementary School
- H-1 and H-2. Samantha Smith Elementary School
- I. Henry David Thoreau Elementary School
- J-1 and J-2. Laura Ingals Wilder Elementary School
- K. Finn Hill Junior High School
- L-1, L-2 and L-3. Inglewood Junior High School
- M. Kamiakin Junior High School
- N-1 and N-2. Site 86
