AN ORDINANCE Changing the name of S.W. 242nd St. to Governors lane petitioned pursuant to Attachment A.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. S.W. 242nd in its entirety is hereby renamed to Governors Lane.

SECTION 2. The public notice requirements contained in Ordinance 8766, Section 10 shall be met. The required number of petition signatures has been satisfied pursuant to Attachment A. Technical advice has been received from the division of building and land development and Fire District No. 13.

SECTION 3. The director of public works shall accomplish the necessary sign changes within sixty days of the passage of this ordinance.
