ORDINANCE NO.

1
2 AN ORDINANCE establishing the date of an
3 election on the question of annexation to
4 the City of Des Moines and adoption of
5 the proposed zoning regulations enacted
6 in the City of Des Moines Ordinance No.
7 816 within an area contiguous to the city
8 known as "North Hill Two Annexation
9 Area."

10 STATEMENT OF FACT:

11 1. The City of Des Moines, Washington, by Resolution
12 No. 696 has determined that it is in the public
13 interest, health, safety and general welfare to
14 provide for annexation of an area known as North Hill
15 Two Annexation Area in accordance with Chapter
16 35A.14.015 RCW.

17 2. Said resolution does satisfy the provisions of
18 RCW 35A.14.010 for qualification for annexation.

19 3. The City of Des Moines, by Resolution No. 696,
20 July 9, 1992, concurs in the annexation of the area
21 known as North Hill Two Annexation Area as provided
22 by RCW 35A.14.050.

23 4. Pursuant to the provisions of RCW 36.93.100, the
24 Boundary Review Board invoked jurisdiction on
25 September 1, 1992, and in accordance held a public
26 hearing regarding the proposed annexation on October
27 27, 1992.

28 5. On November 13, 1992, the Boundary Review Board
29 filed it's written decision approving the proposed
30 annexation as submitted.

31 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

32 SECTION 1. A special election shall be held on the 2nd
33 day of February, 1993, in accordance with RCW 35A.14.050 to be
34 held within the territory of the proposed annexation for the
35 purpose of submitting to the qualified voters within said
36 territory the questions of annexation and adoption of the
37 proposed zoning regulations.

38 SECTION 2. The approximate number of voters within the
39 subject area is found to be 959.

40 SECTION 3. The ballot title, as directed by statute,
41 should be substantially as follows:

PROPOSITION:

- For annexation to the city of Des Moines and adoption of the proposed zoning regulation for the annexation area enacted in city of Des Moines Ordinance No. 816.
- Against annexation.

SECTION 4. The boundaries of the territory proposed for annexation are hereby described as follows:

Beginning at the intersection of the north margin of South 208th Street and west margin of Des Moines Memorial Drive, said point being located in the SE 1/4, Sec. 5, Twn 22N, R 4E, W.M., King County and the true point of beginning of this description;

Thence northerly along said west margin also the SeaTac city limits to its intersection with the north margin of South 200th Street;

Thence westerly and northwesterly along the north margin of South 200th Street and South 199th Street to its intersection with east margin of 1st Avenue South, also the Normandy Park city limit;

Thence southerly along said east margin, also Normandy Park city limits to its intersection with the northerly margin of South 208th Street;


Thence easterly along said northerly margin to its intersection with the west margin of Des Moines Memorial Drive, said intersection also being the true point of beginning of this description.

SECTION 5. The notice of election shall be published as required by law.


