ORDINANCE NO. 10654

AN ORDINANCE relating to vehicle parking adjacent to the Kingdome; setting the parking rate and hours of availability in the Kingdome parking lots; amending Ordinance No. 7017, Section 4, as amended, and K.C.C. 22.12.030.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 7017, Section 4, as amended, and K.C.C. 22.12.030 are each hereby amended to read as follows:

Parking. A. Daily Parking Fees

Any person parking a vehicle in any Kingdome parking lot on a daily basis will pay according to the following schedule:

1. Non-Event Day Parking (includes sales tax):

North Parking Lot

Days, 0 to 3 hours (~~(7 north parking lot)~~) \$3.00 per parking stall
~~((includes sales tax))~~

Days, over 3 hours \$5.00 per parking stall
until 12:00 midnight (~~(7 north parking lot)~~)
~~((includes sales tax))~~

Evenings, from 5:00 p.m. until 12:00 midnight (~~(7 north parking lot)~~) \$3.00 per parking stall
~~((includes sales tax))~~

South Parking Lot and Lot C

Evenings (~~(7 south parking lot)~~) \$2.00 per parking stall
(5:00 p.m. until 12:00 midnight) ~~((includes sales tax))~~

Days (~~(7 south parking lot)~~) \$2.00 per parking stall
(6:30 a.m. to 5:00 p.m.) ~~((includes sales tax))~~

Daily parking is subject to availability, as determined by the director of the department of stadium administration.

2. Event Day Parking in all Kingdome lots (includes sales tax):

Vehicles under 23 feet in length

For Seattle professional football games

Vehicles containing 2 or less \$6.00 per event

1 passengers ((includes sales tax))

 3 passengers ((includes sales tax))

20 B. Monthly Parking Fees

21 Any person or organization choosing to park a vehicle
 22 in the Kingdome ((north)) parking lots on a monthly basis will
 23 pay according to the following schedule:

24 1. Individual Rate_ ((~~\$60.00~~)
 25 North Parking Lot \$65.00 per parking ((stall))
 26 space (plus sales tax)
 27 South Parking Lot or Lot C \$40.00 per parking space
 28 (plus sales tax)

29 The individual rate allows parking from 5:00 a.m. to
 30 12:00 midnight on non-event days; parking is also permitted on
 31 event days based on times established by the stadium's
 32 department director.

The carpooling rate allows parking from 5:00 a.m. to

administration department director.

Provided that:

The daily and monthly parking fees established in this
section will not apply to any person or organization whose
parking fees are established under a separate negotiated
contract between the department of stadium administration and
said person or organization.

C. Effective date. The effective date of this action
is January 1, (~~(1991)~~) 1993.


