 AN ORDINANCE establishing the date for an election on the question of annexation of the City of Woodinville into the King County Rural Library District and declaring an emergency.

ORDINANCE NO.

FINDINGS OF FACT:

The City of Woodinville, Washington by Ordinance No. 002, has initiated the proposed annexation and expressed its intent to join the King County Rural Library District, finding that the public interest will be served thereby. The Woodinville City Council has voted in support of annexation as confirmed in correspondence dated December 29, 1992. Since there is no city-appointed library board, the state librarian has been notified per RCW 27.12.360.

City of Woodinville Ordinance No. 002 does satisfy the provisions of RCW 27.12.010(5), and 27.12.360 requesting the calling of an election to be held among the qualified voters therein.

The Board of Trustees of the King County Rural Library District by Resolution No. 1992-12 has concurred with the proposal as submitted on December 17, 1992, all in accordance with RCW 27.12.360.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. A special election shall be held on the 9th day of March, 1993, within the City of Woodinville. The ballot proposition shall be in substantially the following form in accordance with RCW 27.12.370:

"Shall the City of Woodinville, Washington be annexed to and be part of the King County Rural Library District?"

SECTION 2. Notice of election shall be published as required by law.

SECTION 3. The county council finds as a fact and declares that an emergency exists and that this ordinance is
