AN ORDINANCE making a supplemental appropriation in the amount of \$8,000,000 to the Parks Land Acquisition - 1993 Fund, from various sources for the purpose of acquiring approximately one square mile of land legally described in Section 2 of this ordinance, and amending Ordinance 10641, Section 109, and Attachment 2, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$8,000,000 to the Parks Land Acquisition 1993 Fund (Fund 3401), CIP Project No. 340101, Section 36 Acquisition, from Real Estate Excise Tax (REET) #1 Bond proceeds for the purpose of acquiring Section 36.

SECTION 2. Section 36, the land referred to above is legally described as:

All of Section 36, Township 25, North, Range 6 East, W.M. in King County, Washington.

SECTION 3. Ordinance No. 10641, Section 109, as amended, is hereby amended by adding thereto and inserting therein the following:

From the several capital improvement project funds there are hereby appropriated and authorized to be disbursed the following amounts for the specific projects identified in Attachment No. 2 of this ordinance.

Fund Capital Fund

SECTION 4. Ordinance 10641, Section 109, Attachment 2, as amended, is hereby amended by adding thereto and inserting therein the following:
