AN ORDINANCE relating to the annexation of an area known as Brunton No. 37 to Cedar River Water and Sewer District for water service only

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area for water service known as Brunton No. 37 to Cedar River Water and Sewer District was filed with the county council effective February 3, 1993.

2. Cedar River Water and Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 3085 concurred with the proposed annexation.

3. Cedar River Water and Sewer District filed a Declaration of Non-significant Impact dated November 17, 1992, on the proposed annexation.

4. The county council held a public hearing on the 8th day of March, 1993 and has considered the criteria set forth in R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Cedar River Water and Sewer District of the area known as Brunton No. 37 and described in Section 4 herein is approved.

SECTION 2. The Cedar River Water and Sewer District is the appropriate entity to serve the area proposed to be annexed for water service only.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

SECTION 4. The area known as Brunton No. 37 to be annexed is:

That portion of Section 10, TWP 22 North, Range 6 East W.M., in King County, Washington described as follows:

Beginning at the Southeast corner of said Section 10;
Thence Westerly along the South line thereof to the Southeast corner of the Southwest quarter of the Southeast quarter of said Section 10;

1 Thence Northerly along the East line of said subdivision to
2 the Northeast corner thereof;

3 Thence Westerly along the North line of said subdivision to
4 the Southeast corner of the West half of the West half of
5 the Northwest quarter of said Southeast quarter of Section
6 10;

7 Thence Northerly along the East line of said subdivision to
8 the East-West centerline of said Section 10;

9 Thence Westerly along said East-West centerline to the
10 Northwest corner of the Northeast quarter of the Southwest
11 quarter of said Section 10;

12 Thence Southerly along the West line of said subdivision to
13 the North margin of the right-of-way of the Taylor Branch
14 of the Burlington Northern Railroad;

15 Thence Westerly along said North margin to its intersection
16 with the Southerly margin of primary State Highway No. 2
17 (SR 18);

18 Thence Northeasterly along said Southeasterly margin and
19 the Northeasterly extension thereof to the East line of
20 said Section 10;

21 Thence Southerly along said East line to the Point of
22 Beginning

23 TOGETHER WITH the West 30.00 feet of Section 11, Township
24 22 North, Range 6 East W.M., in King County, Washington.

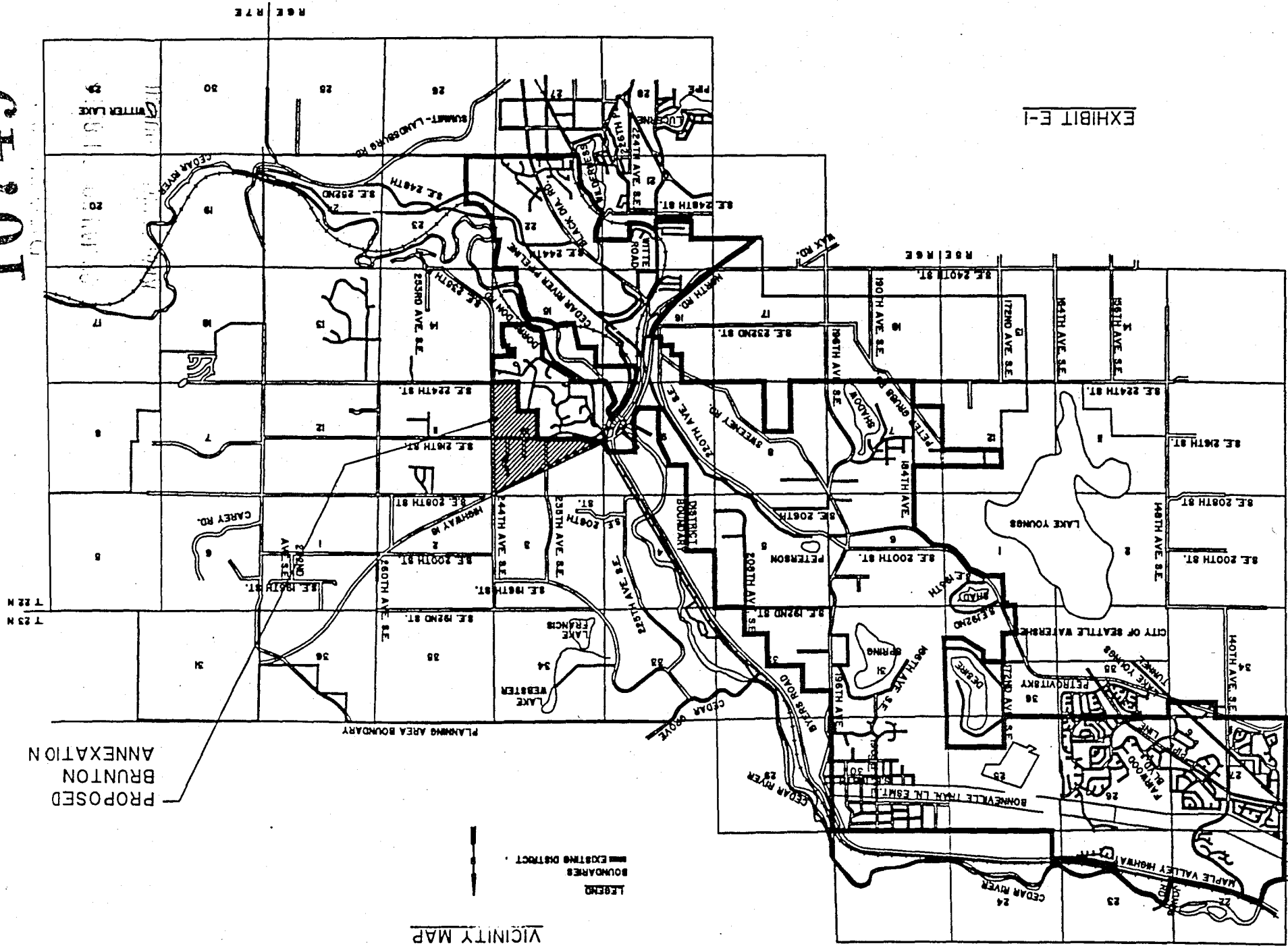
