

ORDINANCE NO. **10903**

AN ORDINANCE relating to the annexation of
an area known as 82-11B to Southwest
Suburban Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an
area known as 82-11B to Southwest Suburban Sewer District was
filed with the county council effective May 26, 1993.

2. Southwest Suburban Sewer District has found the
petition for annexation to be sufficient and has, by Resolution
No. 91-11B concurred with the proposed annexation.

3. Southwest Suburban Sewer District filed a Declaration
of Non-significant Impact statement on the proposed annexation
on September 20, 1992.

4. The county council held a public hearing on the
day of _____, 19____ and has
considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Southwest Suburban Sewer
District of the area known as 82-11B and described in Section 4
herein is approved. This proposed annexation is consistent
with R.C.W. 56.02.060.

SECTION 2. The Southwest Suburban Sewer District is the
appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not
constitute county approval or disapproval of any other permits,
franchises, certifications, or actions necessary to provide
service to this annexation area, nor does it authorize sewer
service in any area not designated as a "Local Service Area" by
the King County Sewerage General Plan.

1 SECTION 4. The area known as 82-11B to be annexed is
2 described as follows:

3 That portion of the Southwest 1/4 of Section 8, Township 23
4 North, Range 4 East, W.M., situated in King County, Washington,
5 described as follows:

6 Beginning at the intersection of the Southerly extension of the
7 West line of the East 12 of Block 13, Cedarhurst Division No.
8 2., according to the plat thereof recorded in Volume 32 of
9 Plats, page 2, Records of King County, Washington, with the
10 centerline of South 128th Street:

11 Thence Northerly along said extended line, said West line and
12 said West line extended northerly to the centerline of South
13 124th Street;

14 Thence Easterly and Southeasterly along said centerline to the
15 West line of the East 149 feet of the Southwest 1/4 of the
16 Southwest 1/4 of said Section 8;

17 Thence Southerly along said West line to its intersection with
18 the centerline of South 128th Street;

19 Thence Westerly along said centerline to the TRUE POINT OF
20 BEGINNING.
