ORDINANCE NO. **11041**

AN ORDINANCE relating to King County district court electoral district boundaries, amending Ordinance 8488, Section 20, Ordinance 8935, Section 5, Ordinance 10476, Section 2, Ordinance 884, Section 1, and K.C.C. 2.68.310, 2.68.075, 2.68.085 and 1.12.010.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 8488, Section 20 and K.C.C. 2.68.310 are hereby repealed.

SECTION 2. Ordinance 8935, Section 5 and K.C.C. 2.68.075 are hereby amended to read as follows:

2.68.075 Electoral Districts - Established - Provisions.

A. District court judges shall be elected to the King County district court from electoral districts defined in Section(~~s .080, .100, .120, .140, .180, .200, .240, .260, .290~~ of this chapter as authorized by ~~SHB 1455~~) **2.68.085**. The precise number of judges elected from each electoral district shall be determined by the county council on or before May 1, 1990, and on or before May 1, of each fourth year thereafter.

B. All candidates for King County district court must file for and be elected in one of the district court electoral districts created by this chapter. Any candidate for King County district court must be a registered voter and legal resident of the district court electoral district within which he or she files.

SECTION 3. Ordinance 10476, Section 2 and K.C.C. 2.68.085 are hereby amended to read as follows:

2.68.085 Electoral District Boundaries. The Seattle electoral district shall be:

All of the area within the following described line:

All of the area within the boundary of the city of Seattle which includes to the centerline of the waters of Puget Sound and the centerline of Lake Washington.

The boundaries of the other electoral districts shall

2 as listed below which are incorporated herein by reference, and
3 which shall be retained officially on file in the division of
4 records and elections, with copies maintained by the clerk of
5 the council and the presiding judge of district court. The

8 council pursuant to K.C.C. 1.12.010:

17 Provided, that the Northeast electoral district shall
18 extend to the corporate boundaries of the City of Bothell.

19 SECTION 4. Ordinance 884, Section 1 and K.C.C. 1.12.010
20 are hereby amended to read as follows:

21 1.12.010 Establishment and revision of precincts. A.
22 Precinct Establishment. The voting precincts of King County
23 are hereby established pursuant to state law and shall be as
24 described in the attachments to this section which are hereby
25 adopted, and which shall be retained officially on file in the
26 division of records and elections.

27 B. Precincts Identified. An alpha-numeric system of
28 identifying voting precincts using a combination of letters and
29 numbers shall be established throughout King County. Those
30 precincts located in unincorporated areas of the county which
31 presently have names shall retain them for public purposes in
32 addition to the alpha-numeric designation. Names shall be
33 given only to those new precincts in unincorporated areas of
34 the county which are created from portions of existing named
35 precincts.

36 C. Precinct Revisions. Precincts shall be divided, new
37 precincts created, and boundaries of existing precincts
38 altered, as necessary, to implement precinct balancing, and to
39 accommodate the incorporation and annexations of unincorporated

1 county areas into incorporated cities and for the convenience
2 of voters.

3 D. Precinct Balancing. In balancing precincts, voting
4 precincts shall be constructed so as to consist of between two
5 hundred and four hundred registered voters per individual
6 precinct. Where necessary to construct a precinct with less
7 than two hundred representation, it shall be noted on the
8 revision proposal and a full explanation of this deviation
9 provided.

10 E. Revision Approval. Proposed revisions to voting
11 precincts, as provided for in this section, shall be submitted
12 to the council for approval by ordinance no later than May 1st
13 of the applicable year. The proposal shall include a
14 replacement for the attachments to this section.

15 F. King County District Court Electoral District
16 Boundaries. The records and elections division shall submit to
17 the council concurrently with any proposed revisions to voting
18 precincts, proposed revisions to the King County district court
19 electoral district boundaries which result from the proposed
20 voting precinct revisions, as described in K.C.C. 2.68.
