AN ORDINANCE relating to drug-free zones; approving maps of the location and boundaries unlawful transactions in controlled

section to K.C.C. 12.82

PREAMBLE:

September 17, 1993

K.C.C. 12.82 establishes a procedure for the production or reproduction of maps depicting the location and boundaries of parks, schools and areas within one thousand feet of schools, within which unlawful transactions in controlled substances are subject to enhanced penalties as imposed pursuant to RCW 69.50.435. The King County parks division has prepared maps depicting such park boundaries. in the public interest to provide notice of the location of such areas and to expedite prosecution, conviction, and enhanced penalties for cases of unlawful transactions in controlled substances in such locations.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The boundaries of drug-free zones surrounding the following parks as listed in Exhibits "A" through "K" located within King County are hereby adopted:
