ORDINANCE NO. 11121

AN ORDINANCE providing for the issuance and public sale of limited tax levy general obligation bonds of the county in the aggregate principal amount of not to exceed \$120,000,000 for the purpose of providing part of the funds to acquire real and personal property for county purposes, construct capital improvements to county facilities, make capital grants to educational, arts and cultural organizations and refund certain outstanding limited tax levy general obligation bonds of the county; providing for the date, form, terms and maturities of said bonds; providing for the public sale of the bonds and the disposition of the proceeds of sale, establishing funds for the receipt and expenditure of bond proceeds and for the payment of the bonds; and providing for the annual levy of taxes to pay the principal thereof and interest thereon.

PROPOSED NO. 93-807

ORDINANCE NO. 11121

AN ORDINANCE providing for the issuance and public sale of limited tax levy general obligation bonds of the county in the aggregate principal amount of not to exceed \$120,000,000 for the purpose of providing part of the funds to acquire real and personal property for county purposes, construct capital improvements to county facilities, make capital grants to educational, arts and cultural organizations and refund certain outstanding limited tax levy general obligation bonds of the county; providing for the date, form, terms and maturities of said bonds; providing for the public sale of the bonds and the disposition of the proceeds of sale; establishing funds for the receipt and expenditure of bond proceeds and for the payment of the bonds; and providing for the annual levy of taxes to pay the principal thereof and interest thereon.

PREAMBLE:

The county council has received and reviewed plans for the following projects:

- A. improvements to the Harborview Medical Center;
- B. acquisition of real property for open space and conservation purposes;
- C. improvements to the Kingdome;
- D. capital construction grants to the Village Theatre, the Pacific Science Center and the Paramount Theatre;
- E. county information systems;
- F. improvements to the King County Courthouse; and
- G. acquisition and renovation of a public safety facility.

The county has previously issued its Limited Tax General Obligation Bonds, 1986 Series C in the aggregate principal amount of \$33,755,000 of which \$20,000,000 can be called prior to maturity. The county has an opportunity to refund those bonds and realize savings to taxpayers.

It is deemed necessary and advisable that the county now issue and sell not to exceed \$120,000,000 of its limited tax levy general obligation bonds in a single issue to acquire, construct, equip and install such capital improvements, to make such grant and to refund certain outstanding bonds of the county.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Definitions. The following words and terms as used in this ordinance shall have the following meanings for all purposes of this ordinance, unless some other meaning is plainly intended.

- A. "Acquired Obligations" means the investments now or hereafter required by the county to effect the refunding of the Refunded Bonds.
- B. "Arbitrage and Tax Certification" means the certificate executed by the County Finance Manager pertaining to the calculation and payment of any Rebate Amount with respect to the Bonds.
- C. "Bond Fund" means the "1993 Series B Limited Tax General Obligation Bond Redemption Account" established pursuant to Section 22 hereof.
- D. "Bond Register" means the registration books maintained by the Bond Registrar for purposes of identifying ownership of the Bonds.
- E. "Bond Registrar" means the fiscal agency of the State of Washington in either Seattle, Washington, or New York, New York, for the purposes of registering and authenticating the Bonds, maintaining the Bond Register, effecting the transfer of ownership of the Bonds and paying interest on and principal of the Bonds.
- F. "Bonds" or "Bond" means all or a portion of the King County, Washington, Limited Tax General Obligation and Refunding Bonds (Various Purpose), 1993 Series B, issued pursuant to this ordinance.
- G. "Code" means the Internal Revenue Code of 1986, as amended, together with corresponding and applicable final, temporary or proposed regulations and revenue rulings issued or amended with respect thereto by the United States Treasury Department or the Internal Revenue Service, to the extent applicable to the Bonds.
- H. "County Finance Manager" means the manager of the finance division of the King County office of financial management or any other county officer who succeeds to the duties now delegated to that office.
 - I. "DTC" means the Depository Trust Company, New York, New York.
- J. "Escrow Agent" means the financial institution chosen pursuant to Section 20 hereof.
- K. "Escrow Agreement" means the agreement between the county and the Escrow Agent with respect to the defeasance of the Refunded Bonds.

L. "Letter of Representations" shall mean that letter substantially in the form of Exhibit B, attached hereto and incorporated herein by this reference.

M. "Rebate Amount" means the amount, if any, determined to be payable with respect to the Bonds by the county to the United States of America in accordance with Section 148(f) of the Code.

N. "Refunded Bonds" means the Limited Tax General Obligation Bonds, 1986 Series C of the county dated August 1, 1986, as authorized pursuant to Ordinance No. 7711 passed on July 28, 1986, and maturing on and after December 1, 1997.

SECTION 2. Findings. The King County council hereby makes the following findings:

A. The following projects, all as more fully described in Exhibit A hereto, will contribute to the health, safety and welfare of the citizens of the county: capital improvements to the Harborview Medical Center; acquisition of real property for open space and parks purposes; improvements to the Kingdome; capital construction grants to the Village Theatre, the Pacific Science Center and the Paramount Theatre; county information systems; improvements to the King County Courthouse and acquisition and renovation of a public safety facility.

- B. Significant debt service savings can be realized by the county through the defeasance and early redemption of the Refunded Bonds.
- C. The issuance of a single series of limited tax levy general obligation bonds to pay the costs of the projects approved in Section 3 hereof and to refund the Refunded Bonds, payable from regular property taxes, will reduce the overall costs of borrowing such funds and is in the best interests of the county and its citizens.

SECTION 3. Authorization of Projects and Grant. The county is hereby authorized to acquire, construct, equip and make the capital improvements and proceed with the projects as specified in Exhibit A hereto and incorporated herein by reference. The costs of such projects shall also include interest on any interim financing for such projects pending receipt of Bond proceeds and certain costs and expenses incurred in issuing the Bonds.

The projects authorized herein shall include the costs of sales tax, acquisition and contingency allowances, financing, and any and all surveys, explorations, engineering and architectural studies, drawings, designs and specifications incidental, necessary or convenient to the improvements herein specified. Such projects shall also include the purchase of all materials, supplies, appliances, equipment and facilities, and the permits, franchises, property and property rights and administrative costs, necessary, incidental or convenient to effect the improvements.

The projects authorized herein may be modified where deemed advisable or necessary in the judgment of the county council, and implementation or completion of any authorized project shall not be required if the county council determines that it has become inadvisable or impractical. If all of the projects either have been completed, or their completion duly provided for, or their completion found to be inadvisable or impractical, the county may apply any remaining proceeds of the Bonds, or any portion thereof, to the acquisition or improvement of other county facilities as the county council in its discretion may determine. In the event that the proceeds of the sale of the Bonds, plus any other moneys of the county legally available therefor, are insufficient to accomplish all of the projects authorized in this section, the county shall use the available funds for paying the cost of those improvements for which the Bonds were authorized deemed by the county council most necessary and in the best interest of the county.

The county is further authorized to make the capital grants described in Exhibit A hereto.

SECTION 4. Purpose, Authorization and Description of Bonds; Use of Depository.

A. <u>Purpose and Authorization of Bonds</u>. The county shall now issue and sell not more than \$120,000,000 of the Bonds for the purpose of providing the county with part of the funds required to pay the cost of the projects and capital grant authorized in Section 3 hereof and to refund the Refunded Bonds.

Following the opening of bids to purchase the Bonds, the aggregate principal amount and any single maturity amount may be increased or decreased by the amount necessary to effect the refunding of the Refunding Bonds, provided that the aggregate principal amount of the Bonds shall not exceed \$120,000,000 and the price bid shall be adjusted accordingly. The aggregate principal amount shall be established in accordance with Section 26 hereof.

B. <u>Description</u>. The Bonds shall be designated "Limited Tax General Obligation and Refunding Bonds (Various Purpose), 1993 Series B. The Bonds shall be in a principal amount not exceeding \$120,000,000, shall be fully registered as to both principal and interest, shall be in the denomination of \$5,000 each or any integral multiple thereof (but no Bond shall represent more than one maturity), shall be numbered separately in such manner and with any additional designation as the Bond Registrar deems necessary for purposes of identification, shall be dated as of such date and shall mature on the dates, in the years and in the amounts established in accordance with Section 26 hereof.

The Bonds shall bear interest (computed on the basis of a 360-day year of twelve 30-day months) from their date or from the most recent interest payment date for which interest has been

paid or duly provided for, whichever is later, payable on July 1, 1994, and semiannually thereafter on the first days of each succeeding July and January to the maturity or earlier redemption of the Bonds, at the rate or rates bid by the successful bidder at public sale and accepted by motion of the county council.

The Bonds shall be negotiable instruments to the extent provided by RCW 62A.8-105.

Initial Immobilization of Bonds; Depository Provisions. The Bonds initially shall be C. held in fully immobilized form by DTC acting as depository pursuant to the terms and conditions set forth in the Letter of Representations set forth in Exhibit B hereto and by this reference incorporated herein. To induce DTC to accept the Bonds as eligible for deposit at DTC, the County Finance Manager is authorized to execute the Letter of Representations, with such changes as hereafter may be approved by him, and such approval shall be conclusively presumed by the County Finance Manager's execution thereof. Neither the county nor the Bond Registrar shall have any responsibility or obligation to DTC participants or the persons for whom they act as nominees with respect to the Bonds with respect to the accuracy of any records maintained by DTC or any DTC participant, the payment by DTC or any DTC participant of any amount in respect of principal or redemption price or interest on the Bonds, any notice which is permitted or required to be given to Registered Owners under this ordinance (except such notice as is required to be given by the county to the Bond Registrar or to DTC), the selection by DTC or any DTC participant of any person to receive payment in the event of a partial redemption of the Bonds or any consent given or other action taken by DTC as owner of the Bonds.

The Bonds initially shall be issued in denominations equal to the aggregate principal amount of each maturity and initially shall be registered in the name of CEDE & CO., as the nominee of DTC. The Bonds so registered shall be held in fully immobilized form by DTC as depository. For so long as any Bonds are held in fully immobilized form, DTC, its successor or any substitute depository appointed by the county, as applicable, shall be deemed to be the Registered Owner for all purposes hereunder and all references to Registered Owners, bondowners, bondholders, owners or the like shall mean DTC or its nominees and shall not mean the owners of any beneficial interests in the Bonds. Registered ownership of such Bonds, or any portions thereof, may not thereafter be transferred except:

1. To any successor of DTC or its nominee, if that successor shall be qualified under any applicable laws to provide the services proposed to be provided by it;

2. To any substitute depository appointed by the county pursuant to this subsection or such substitute depository's successor; or

To any person as herein provided if the Bonds are no longer held in immobilized form.

Upon the resignation of DTC or its successor (or any substitute depository or its successor) from its functions as depository, or a determination by the county that it is no longer in the best interests of beneficial owners of the Bonds to continue the system of book entry transfers through DTC or its successor (or any substitute depository or its successor), the county may appoint a substitute depository. Any such substitute depository shall be qualified under any applicable laws to provide the services proposed to be provided by it.

In the case of any transfer pursuant to clause (1) or (2) of the second paragraph of this subsection, the Bond Registrar, upon receipt of all outstanding Bonds together with a written request on behalf of the county, shall issue a single new Bond for each maturity of Bonds then outstanding, registered in the name of such successor or such substitute depository, or their nominees, as the case may be, all as specified in such written request of the county.

In the event that DTC or its successor (or substitute depository or its successor) resigns from its functions as depository, and no substitute depository can be obtained; or the county determines that it is in the best interests of the beneficial owners of the Bonds that they be able to obtain Bond certificates, the ownership of Bonds may be transferred to any person as herein provided, and the Bonds shall no longer be held in fully immobilized form. The county shall deliver a written request to the Bond Registrar, together with a supply of definitive Bonds, to issue Bonds as herein provided in any authorized denomination. Upon receipt of all then outstanding Bonds by the Bond Registrar, together with a written request on behalf of the county to the Bond Registrar, new Bonds shall be issued in such denominations and registered in the names of such persons as are requested in such a written request.

D. Place, Manner and Medium of Payment. Both principal of and interest on the Bonds shall be payable in lawful money of the United States of America. For so long as outstanding Bonds are registered in the name of CEDE & Co., or its registered assigns, as nominee of DTC, payments of principal of and interest on the Bonds shall be made in next day funds on the date such payment is due and payable at the place and in the manner provided in the Letter of Representations.

 In the event that Bonds are no longer immobilized by DTC, interest on the Bonds shall be paid by checks or drafts mailed, or by wire transfer, to owners of Bonds at the addresses for such owners appearing on the Bond Register on the 15th day of the calendar month preceding the interest payment date. Wire transfer will be made only if so requested in writing and if the owner owns at least one million dollars (\$1,000,000) par value of the Bonds. Principal of the Bonds shall be payable at maturity or on such dates as may be fixed for prior redemption upon presentation and surrender of the Bonds by the owners at either principal office of the Bond Registrar in Seattle, Washington, or New York, New York, at the option of such owners.

SECTION 5. Optional Redemption of Bonds. The county may reserve the right to redeem outstanding Bonds prior to their maturity on the dates and at the prices determined by motion of the county council upon sale of the Bonds in accordance with Section 26 hereof. Portions of the principal amount of any Bond, in increments of \$5,000 or any integral multiple of \$5,000, may be redeemed. If less than all of the principal amount of any Bond is redeemed, upon surrender of such Bond at the principal office of the Bond Registrar there shall be issued to the registered owner, without charge therefor, for the then unredeemed balance of the principal amount thereof, a new Bond or Bonds, at the option of the registered owner, of like maturity and interest rate in any denomination authorized by this ordinance.

All Bonds purchased or redeemed under this section shall be canceled by the Bond Registrar and shall not be reissued.

SECTION 6. Notice and Effect of Redemption. Unless waived by the registered owner of Bonds to be redeemed or the nominee of such owner, official notice of any such redemption shall be given by the Bond Registrar on behalf of the county by mailing a copy of an official redemption notice by certified or registered mail, postage prepaid, not less than 30 nor more than 60 days prior to the date fixed for redemption, to the registered owner of the Bond or Bonds to be redeemed at the address shown on the Bond Register or at such other address as is furnished in writing by such registered owner to the Bond Registrar.

All official notices of redemption shall be dated and shall state:

- A. the redemption date;
- B. the redemption price;
- C. if less than all outstanding Bonds are to be redeemed,
 the identification (and, in the case of partial redemption, the respective principal amounts) of the Bonds to be redeemed;

D. that on the redemption date the redemption price will become due and payable upon each such Bond or portion thereof called for redemption, and that interest thereon shall cease to accrue from and after said date; and

E. the place where such Bonds are to be surrendered for payment of the redemption price, which place of payment shall be either of the principal offices of the Bond Registrar.

Such notice of redemption shall be mailed within the same period, postage prepaid, to Moody's Investors Service, Inc. and Standard & Poor's Corporation at their offices in New York, New York, or their successors, and to such other persons and with such additional information as the County Finance Manager shall deem appropriate, but such mailings shall not be a condition precedent to the redemption of the Bonds.

Prior to any redemption date, the county shall deposit with the Bond Registrar an amount of money sufficient to pay the redemption price of all the Bonds or portions of Bonds which are to be redeemed on that date.

Official notice of redemption having been given as aforesaid, the Bonds or portions of Bonds so to be redeemed shall, on the redemption date, become due and payable at the redemption price therein specified, and from and after such date (unless the county shall default in the payment of the redemption price upon presentation) such Bonds or portions of Bonds shall cease to bear interest. Upon surrender of such Bonds for redemption in accordance with said notice, such Bonds shall be paid by the Bond Registrar at the redemption price. Installments of interest due on or prior to the redemption date shall be payable as herein provided for payment of interest. Upon the payment of the redemption price of Bonds being redeemed, each check or other transfer of funds issued for such purpose shall bear the CUSIP number identifying, by issue and maturity, the Bonds being redeemed with the proceeds of such check or other transfer. Upon surrender for any partial redemption of any Bond, there shall be prepared for the registered owner a new Bond or Bonds of the same maturity in the amount of unpaid principal.

In addition to the foregoing notice, further notice shall be given by the Bond Registrar as set out below, but no defect in said further notice nor any failure to give all or any portion of such further notice shall in any manner defeat the effectiveness of a call for redemption if notice thereof is given as above prescribed.

1. Each further notice of redemption given hereunder shall contain the information required above for an official notice of redemption plus: the CUSIP numbers of all Bonds being redeemed; the date of issue of the Bonds as originally issued; the rate of interest borne by each

Bond being redeemed; the maturity date of each Bond being redeemed; and any other descriptive information needed to identify accurately the Bonds being redeemed. 2 Each further notice of redemption shall be sent at least 35 days before the redemption date by registered or certified mail or overnight delivery service to all registered securities depositories then in the business of holding substantial amounts of obligations of types comprising the Bonds (such depositories now being Depository Trust Company of New York, New York, Midwest Securities Trust Company of Chicago, Illinois, Pacific Securities Depository Trust Company of San Francisco, California, and Philadelphia Depository Trust Company of Philadelphia, Pennsylvania). The requirements of this section shall be deemed to be complied with when notice is mailed as herein provided, whether or not it is actually received by the owner. SECTION 7. Form of Bonds. capital improvements to certain County facilities and projects, make a capital construction grant and to refund certain outstanding bonds of the County.

The bonds of this series are issued under and in accordance with the provisions of the Constitution and applicable statutes of the State of Washington, the County Charter and applicable ordinances duly adopted by the County.

The County has reserved the right to redeem outstanding bonds of this series maturing on 1, 200 in whole on any date or in part on any interest payment date, on or 1, 200, maturities to be redeemed to be selected by the county (and by lot within a maturity, in increments of \$5,000, with the manner of selection to be as chosen by the Bond Registrar) at par plus accrued interest to the date of redemption.

Portions of the principal sum of this bond in installments of \$5,000 or any integral multiple thereof also may be redeemed in accordance with the provisions set forth above, and if less than all of the principal sum hereof is to be redeemed, upon the surrender of this bond at the principal offices of the Bond Registrar there shall be issued to the Registered Owner, without charge therefor, for the then unredeemed balance of the principal sum hereof, at the option of the owner, a bond or bonds of like maturity and interest rate in any of the denominations authorized by the Bond Ordinance.

Notice of redemption, unless waived, is given by the Bond Registrar by mailing an official redemption notice by certified or registered mail, postage prepaid, not less than 30 days and not more than 60 days prior to the date fixed for redemption, to the Registered Owner of any bond to be redeemed at the address appearing on the Bond Register. The requirements for such notice shall be deemed to be complied with when notice is mailed as herein provided, regardless of whether or not it is actually received by the owner of any bond.

If such notice has been given and if the County has set aside, on the date fixed for redemption, sufficient money for the payment of all bonds called for redemption, the bonds so called shall cease to accrue interest after such redemption date, and all such bonds shall no longer be deemed to be outstanding for any purpose, except that the Registered Owners thereof shall be entitled to receive payment of the redemption price and accrued interest to the redemption date from the money set aside for such purpose.

The County hereby irrevocably covenants and agrees with the owner of this bond that it will annually include in its budget and levy taxes, within and as a part of the tax levy permitted to counties without a vote of the electorate upon all the property subject to taxation, in an amount sufficient, together with all other moneys legally available therefor, to pay the principal of and interest on this bond as the same shall become due. The full faith, credit and resources of the County are hereby irrevocably pledged for the annual levy and collection of such taxes and the prompt payment of such principal and interest.

The pledge of tax levies for repayment of principal of and interest on the bonds may be discharged prior to maturity of the bonds by making provisions for the payment thereof on the terms and conditions set forth in the Bond Ordinance.

The following abbreviations, when used in the inscription on the face of the within bond, shall be construed as though they were written out in full according to applicable laws or regulations.

SECTION 8. Execution of Bonds. The Bonds shall be executed on behalf of the county with the manual or facsimile signatures of the county executive and the clerk of the council, and shall have the seal of the county impressed or imprinted thereon.

In case either or both of the officers who shall have executed the Bonds shall cease to be an officer or officers of the county before the Bonds so signed shall have been authenticated or delivered by the Bond Registrar, or issued by the county, such Bonds may nevertheless be authenticated, delivered and issued and upon such authentication, delivery and issuance, shall be as binding upon the county as though those who signed the same had continued to be such officers of the county. Any Bond also may be signed and attested on behalf of the county by such persons as at the actual date of execution of such Bond shall be the proper officers of the county although at the original date of such Bond any such person shall not have been such officer of the county.

Only such Bonds as shall bear thereon a Certificate of Authentication in the form hereinbefore recited, manually executed by the Bond Registrar, shall be valid or obligatory for any purpose or entitled to the benefits of this ordinance. Such Certificate of Authentication shall be conclusive evidence that the Bonds so authenticated have been duly executed, authenticated and delivered hereunder and are entitled to the benefits of this ordinance.

SECTION 9. Bond Registrar. The Bond Registrar shall keep, or cause to be kept, at its principal corporate trust office, sufficient books for the registration and transfer of the Bonds which shall at all times be open to inspection by the county. Such Bond Register shall contain the name and mailing address of the owner of each Bond or nominee of such owner and the principal amount and number of Bonds held by each owner or nominee.

The Bond Registrar is authorized, on behalf of the county, to authenticate and deliver the Bonds transferred or exchanged in accordance with the provisions of such Bonds and this ordinance and to carry out all of the Bond Registrar's powers and duties under this ordinance.

The Bond Registrar shall be responsible for its representations contained in the Certificate of Authentication on the Bonds. The Bond Registrar may become the owner of Bonds with the same rights it would have if it were not the Bond Registrar, and to the extent permitted by law may act as depository for and permit any of its officers or directors to act as a member of, or in any other capacity with respect to, any committee formed to protect the rights of Bond owners.

Upon surrender thereof to the Bond Registrar, the Bonds are interchangeable for Bonds in any authorized denomination of an equal aggregate principal amount and of the same interest rate and maturity. Bonds may be transferred only if endorsed in the manner provided thereon and surrendered to the Bond Registrar. Upon such surrender, the Bond Registrar shall cancel the surrendered Bond and shall authenticate and deliver, without charge to the owner or transferee therefor, (other than taxes, if any, payable on account of such transfer) a new Bond (or Bonds, at the option of the new registered owner) of the same maturity and interest rate and for the same aggregate principal amount, in any authorized denomination, naming as registered owner the person or persons listed as the assignee on the assignment form appearing on the surrendered Bond, in exchange for such surrendered and canceled Bond. The Bond Registrar shall not be obligated to transfer or exchange any Bond during the fifteen days preceding any interest payment, principal payment or redemption date.

The county and the Bond Registrar, each in its discretion, may deem and treat the registered owner of each Bond as the absolute owner thereof for all purposes, and neither the county nor the Bond Registrar shall be affected by any notice to the contrary.

SECTION 10. Mutilated, Lost, or Destroyed Bonds. If any Bond shall become mutilated, the Bond Registrar shall authenticate and deliver a new Bond of like series, amount, date, interest rate and tenor in exchange and substitution for the Bond so mutilated, upon the owner's paying the expenses and charges of the county and the Bond Registrar in connection therewith and upon surrender to the Bond Registrar of the Bond so mutilated. Every mutilated Bond so surrendered shall be canceled and destroyed by the Bond Registrar.

In case the Bonds or any of them shall be lost, stolen or destroyed, the Bond Registrar may authenticate and deliver a new Bond or Bonds of like amount, date, and tenor to the registered owner thereof upon the owner's paying the expenses and charges of the county and the Bond Registrar in connection therewith and upon his/her filing with the Bond Registrar evidence satisfactory to the Bond Registrar that such Bond or Bonds were actually lost, stolen or destroyed

and of his/her ownership thereof, and upon furnishing the county and Bond Registrar with indemnity satisfactory to the County Finance Manager and the Bond Registrar.

SECTION 11. Covenants and Warranties. The county makes the following covenants and warranties:

- A. The county has full legal right, power and authority to adopt this ordinance, to sell, issue and deliver the Bonds as provided herein, and to carry out and consummate all other transactions contemplated by this ordinance.
- B. By all necessary official action prior to or concurrently herewith, the county has duly authorized and approved the execution and delivery of, and the performance by the county of its obligations contained in the Bonds and in this ordinance and the consummation by it of all other transactions necessary to effectuate this ordinance in connection with the issuance of the Bonds, and such authorizations and approvals are in full force and effect and have not been amended, modified or supplemented in any material respect.
 - C. This ordinance constitutes a legal, valid and binding obligation of the county.
- D. The Bonds, when issued, sold, authenticated and delivered, will constitute the legal, valid and binding general obligations of the county.
- E. Until all Bonds shall have been surrendered and canceled, the county will maintain a system of recording the ownership of each Bond that complies with the applicable provisions of the Code.
- F. The adoption of this ordinance, and compliance on the county's part with the provisions contained herein, will not conflict with or constitute a breach of or default under any constitutional provisions, law, administrative regulation, judgment, decree, loan agreement, indenture, bond, note, resolution, ordinance, motion, agreement or other instrument to which the county is a party or to which the county or any of its property or assets are otherwise subject, nor will any such adoption, execution, delivery, sale, issuance or compliance result in the creation or imposition of any lien, charge or other security interest or encumbrance of any nature whatsoever upon any of the property or assets of the county or under the terms of any such law, regulation or instrument, except as may be provided by the Bonds and this ordinance.
- G. The county finds and covenants that the Bonds are issued within all statutory and constitutional debt limitations applicable to the county.
- H. None of the proceeds of the Bonds will be used for any purpose other than as provided in this ordinance and the county shall not suffer any amendment or supplement to this

ordinance, or any departure from the due performance of the obligations of the county hereunder, which might materially adversely affect the rights of the owners from time to time of the Bonds.

I. The county will make available for inspection by the Bond owners, at the office of financial management, a copy of the latest audit report of the state auditor on the county's books and accounts and will also furnish a copy thereof, upon request, to any Bond owner.

SECTION 12. Application of Bond Proceeds--Harborview Medical Center.

There is hereby created the "Harborview Construction Fund, 1993." The Harborview Construction Fund, 1993 shall be a first tier fund managed by the harborview project office.

There shall be deposited into said fund approximately \$8,510,000 of Bond proceeds at the time of delivery of the Bonds to pay a portion of the costs of acquiring, constructing and equipping improvements to the Harborview Medical Center, as described in Exhibit A hereto, and to pay a portion of the costs of issuing the Bonds.

SECTION 13. Application of Bond Proceeds—Open Space. There has heretofore been created the "Regional Conservation Futures Acquisition Fund" into which Bond proceeds shall be deposited at the time of delivery of the Bonds in the approximate amount of \$60,105,000 to acquire real property for open space purposes, as described in Exhibit A hereto and Ordinance No. 11068, and to pay a portion of the costs of issuing the Bonds.

SECTION 14. Application of Bond Proceeds-Kingdome. There is hereby created the "1993 Series B Kingdome Fund." The 1993 Series B Kingdome Fund shall be a first tier fund managed by the stadium administration department.

There shall be deposited into said fund approximately \$5,360,000 of Bond proceeds at the time of delivery of the Bonds to retire an interfund loan with respect to improvements to the Kingdome, to make additional improvements to the Kingdome, as described in Exhibit A hereto, and to pay a portion of the costs of issuing the Bonds.

SECTION 15. Application of Bond Proceeds—One Percent for Art Fund. There has heretofore been created the "One Percent for Art Fund," into which shall be transferred from the funds herein referenced, the amounts determined by the County Finance Manager to be necessary to comply with the provisions of Section 4.40.040 of the county code. Amounts in such fund shall be used for the purposes authorized by law for deposits in the One Percent for Art Fund.

SECTION 16. Application of Bond Proceeds-Conservation. There has heretofore been created the "Parks Land Acquisition Fund, 1993" pursuant to Ordinance No. 10685, into which Bond proceeds shall be deposited at the time of delivery of the Bonds in the approximate amounts

of \$1,005,000 to acquire real property in the Cedar River basin for conservation purposes, as described in Exhibit A, and to pay a portion of the costs of issuing the Bonds.

SECTION 17. Application of Bond Proceeds—County Acquisition and Renovation. There is hereby created the "Capital Acquisition and Renovation Fund 1993 Series B."

At the time of delivery of the Bonds, there shall be deposited into said fund Bond proceeds in the following approximate amounts for the following projects, as described in Exhibit A hereto:

- Educational and Cultural Facilities \$1,305,000;
- b. County Information Systems \$3,995,000;
- c. Courthouse Improvements \$4,800,000;
- d. Public Safety Facility \$1,605,000.

Amounts in the Capital Acquisition and Renovation Fund 1993 Series B shall also be used to pay a portion of the costs of issuing the Bonds.

SECTION 18. Application of Bond Proceeds—Geographic Information System. There has heretofore been created the "Core GIS Capital Project Fund" into which Bond proceeds shall be deposited at the time of delivery of the bonds in the approximate amount of \$6,845,000 to acquire a geographic information system and \$150,000 for a wide area network, as described in Exhibit A hereto. Amounts in such fund shall also be used to pay a portion of the costs of issuing the Bonds.

SECTION 19. Application of Bond Proceeds—Arts and Historic Preservation. There is hereby created the "Arts and Historic Preservation Capital Fund 1993 Series B." The Arts and Historic Preservation Capital Fund 1993 Series B shall be a first tier fund managed by the office financial management.

There shall be deposited into such fund approximately \$1,005,000 of Bond proceeds at the time of delivery of the Bonds to make a capital grant to the Village Theatre, as described in Exhibit A hereto, and to pay a portion of the costs of issuing the Bonds.

SECTION 20. Application of Bond Proceeds--Refunding.

A. There is hereby created the "1986 LTGO Advance Refunding Account," which account is to be drawn upon for the sole purpose of paying the principal of and interest on the Refunded Bonds and of paying costs related to the refunding of such bonds.

The proceeds of sale of the Bonds in the approximate amount of \$23,100,000 shall be credited to such 1986 LTGO Advance Refunding Account.

Money in the 1986 LTGO Advance Refunding Account shall be used immediately upon receipt thereof to defease the Refunded Bonds and discharge the other obligations of the county

under Ordinance No. 7711, passed July 28, 1986, with respect to the Refunded Bonds, by providing for the payment of the principal of and interest thereon as hereinafter set forth in this section. The county shall defease the Refunded Bonds and discharge such obligations by the use of money in the 1993B Advance Refunding Account to purchase certain noncallable "Government Obligations" as such obligations are defined in Chapter 39.53 RCW as now or hereafter amended (which obligations so purchased, are herein called "Acquired Obligations"), bearing such interest and maturing as to principal and interest in such amounts and at such times which, together with any necessary beginning cash balance will provide for the payment of:

- the interest that will become due and payable on or before December 1, 1996, on the
 Refunded Bonds; and
- the redemption price payable on December 1, 1996, for the principal of the Refunded Bonds.

Such Acquired Obligations shall be purchased at a yield not greater than the yield permitted by the Code for acquired obligations in connection with advance refunding bond issues.

Such Acquired Obligations and any necessary beginning cash balance shall be irrevocably deposited with a banking institution chosen by the County Finance Manager (hereinafter called the "Escrow Agent"). Any amounts described in subparagraphs 1. and 2. of this section which are not provided for in full by such beginning cash balance and the purchase and deposit of Acquired Obligations described in this section shall be provided for by the irrevocable deposit of the necessary amount out of the proceeds of sale of the Bonds or any other monies of the county legally available therefor with the aforesaid Escrow Agent. The proceeds of the Bonds remaining in the 1986 LTGO Advance Refunding Account after acquisition of the Acquired Obligations and provision for the necessary beginning cash balance shall be utilized to pay expenses of the acquisition and safekeeping of the Acquired Obligations and expenses of the issuance of the Bonds. The county may, from time to time, transfer, or cause to be transferred, from the 1986 LTGO Advance Refunding Account any monies not thereafter required for the purposes set forth in 1. and 2. of this section or for the payment of expenses. The county reserves the right to substitute other non-callable securities for the Acquired Obligations in the event it may do so pursuant to Section 148 of the Code, upon compliance with the following conditions:

x. Such substitution is accomplished pursuant to a motion of the county council, which may be adopted either prior to or subsequent to the delivery of the Refunding Bonds.

y. The securities to be substituted are direct, noncallable obligations of, or obligations the principal of and interest on which are unconditionally guaranteed by, the United States of America and bank certificates of deposit secured by such obligations.

- z. Such securities bear such interest and mature at such times and in such amounts as to fully replace the Acquired Obligations for which they are substituted, and to provide, together with Acquired Obligations and cash remaining, for the payment of the amounts specified in items 1, and 2, of this section.
- B. The county shall irrevocably set aside sufficient funds out of the proceeds of Acquired Obligations purchased from proceeds of the Bonds, together with any necessary beginning cash balance, to pay interest on the Refunded Bonds through December 1, 1996, and to redeem the Refunded Bonds maturing after that date, in accordance with the provisions of Section 5 of Ordinance No. 7177 of the county authorizing the redemption and retirement of the Refunded Bonds.

The county hereby calls for redemption on December 1, 1996, the Refunded Bonds in accordance with the provisions of said Ordinance No. 7177 of the county, authorizing the redemption and retirement of the Refunded Bonds prior to their fixed maturities.

Said defeasance and call for redemption of the Refunded Bonds shall be irrevocable after the final establishment of the escrow account and delivery of the Acquired Obligations to the Escrow Agent, except as provided herein for the substitution of securities.

The Escrow Agent is hereby authorized and directed to provide for the giving of notice of the redemption of the Refunded Bonds in accordance with Section 5 of Ordinance No. 7177. The County Finance Manager of the county is authorized and requested to provide whatever assistance is necessary to accomplish such redemption and the giving of notice therefor. The costs of publication of such notice shall be an expense of the county.

The Escrow Agent is hereby authorized and directed to pay to the county, or, at the direction of the County Finance Manager, to the fiscal agency or agencies of the State of Washington, sums sufficient to pay, when due, the payments specified in subparagraphs 1. and 2. above. All such sums shall be paid from the Acquired Obligations deposited with said Escrow Agent pursuant to this section of this ordinance, and the income therefrom and proceeds thereof. All such sums so paid shall be credited to the 1986 LTGO Advance Refunding Account. All monies and Acquired Obligations deposited with the Escrow Agent and any income therefrom shall

be held, invested and applied in accordance with the provisions of this ordinance and with the laws of the State of Washington for the benefit of the county and holders of the Refunded Bonds.

The county will take such actions as are found necessary to see that all necessary and proper fees, compensation and expenses of the Escrow Agent for refunding the Refunded Bonds shall be paid when due. The proper officers and agents of the county are directed to obtain from the Escrow Agent an agreement setting forth the duties, obligations and responsibilities of the Escrow Agent in connection with the redemption and retirement of the Refunded Bonds as provided herein and stating that such provisions for the payment of the fees, compensation and expenses of such Refunding Agent are satisfactory to it.

In order to carry out the purposes of the preceding section of this ordinance and this section, the County Finance Manager is authorized and directed to execute and deliver to the Escrow Agent, a copy of such agreement when the provisions thereof have been fixed and determined.

SECTION 21. Application of Bond Funds—General. The exact amounts to be deposited in accordance with Sections 12 through 20 above shall be determined by the County Finance Manager upon the sale of the Bonds. The amounts so deposited may be used to repay interim borrowing used to pay the costs of the improvements authorized in Section 3 hereof.

Moneys deposited in the funds and accounts established in Sections 12 through 20 above shall be invested as permitted by law for the sole benefit of the respective funds. Irrespective of the general provisions of Ordinance No. 7112 and K.C. 4.10, the county current expense funds shall not receive any earnings attributable to such funds. Moneys other than proceeds of the Bonds may be deposited in the funds and accounts established under Sections 12 through 20 above; provided, that proceeds of the Bonds and earnings thereon shall be accounted for separately for purposes of the calculations required to be made under Section 22 hereof. For purposes of such calculations, Bond proceeds shall be deemed to have been expended first.

SECTION 22. Bond Redemption Fund. There has heretofore been created in the office of financial management of the county a special fund to be drawn upon for the purpose of paying the principal of and interest on the limited tax general obligation bonds of the county. There is hereby created within said fund a special account of the county to be known as the "1993 Series B Limited Tax General Obligation Bond Redemption Account" (the "Bond Fund"). The accrued interest on the Bonds and any proceeds which represent less than the maximum discount permitted in the Official Notice of Bond Sale shall be deposited in the Bond Fund at the time of delivery of the

Bonds and shall be applied to the payment of interest on the Bonds. Any premium received upon the sale of the Bonds shall be deposited into the Bond Fund and applied to the payment of principal of or interest on the Bonds. The taxes hereafter levied for the purpose of paying principal of and interest on the Bonds and other funds to be used to pay the Bonds shall be deposited in the Bond Fund no later than the date such funds are required for the payment of principal of and interest on the Bonds; provided, that if the payment of principal of and interest on the Bonds is required prior to the receipt of such levied taxes, the county may make an interfund loan to the Bond Fund pending actual receipt of such taxes. The Bond Fund shall be drawn upon for the purpose of paying the principal of and interest on the Bonds. Moneys in the Bond Fund not needed to pay the interest or principal next coming due may temporarily be deposited in such institutions or invested in such obligations as may be lawful for the investment of county moneys. The Bond Fund shall be a second tier fund in accordance with Ordinance No. 7112 and K.C. 4.10.

SECTION 23. Pledge of Taxation and Credit. The county hereby irrevocably covenants and agrees for as long as any of the Bonds are outstanding and unpaid, that each year it will include in its budget and levy an ad valorem tax upon all the property within the county subject to taxation in an amount which will be sufficient, together with all other revenues and moneys of the county legally available for such purposes, to pay the principal of and interest on the Bonds as the same shall become due. All of such taxes so collected and any other moneys to be used for such purposes shall be paid into the Bond Fund.

The county hereby irrevocably pledges that the annual tax provided for herein to be levied for the payment of such principal and interest shall be within and as a part of the tax levy permitted to counties without a vote of the people, and that a sufficient portion of each annual levy to be levied and collected by the county prior to the full payment of the principal of and interest on the Bonds will be and is hereby irrevocably set aside, pledged and appropriated for the payment of the principal of and interest on the Bonds.

The full faith, credit and resources of the county are hereby irrevocably pledged for the annual levy and collection of said taxes and for the prompt payment of the principal of and interest on the Bonds as the same shall become due.

SECTION 24 21. <u>Tax-Exemption</u>. The county shall comply with the provisions of this section unless, in the written opinion of nationally-recognized bond counsel to the county, such compliance is not required in order to maintain the exemption of the interest on the Bonds from federal income taxation.

The county hereby covenants that it will not make any use of the proceeds from the sale of the Bonds or any other funds of the county which may be deemed to be proceeds of such Bonds pursuant to Section 148 of the Code and the applicable regulations thereunder which will cause the Bonds to be "arbitrage bonds" within the meaning of said Section and said regulations. The county will comply with the applicable requirements of Section 148 of the Code (or any successor provision thereof applicable to the Bonds) and the applicable regulations thereunder throughout the term of the Bonds.

The county further covenants that it will not take any action or permit any action to be taken that would cause the Bonds to constitute "private activity bonds" under Section 141 of the Code.

SECTION 25. Arbitrage Rebate. The county will pay the Rebate Amount, if any, to the United States of America at the times and in the amounts necessary to meet the requirements of the Code to maintain the federal income tax exemption for interest payments on the Bonds, in accordance with the Arbitrage and Tax Certification.

SECTION 26. Sale of Bonds. The Bonds shall be sold at public sale, substantially in accordance with the terms and conditions of the Official Notice of Bond Sale attached hereto as Exhibit C. The County Finance Manager is hereby authorized to establish a maturity schedule and redemption provisions in the Official Notice of Bond Sale and to make insubstantial modifications to Exhibit C so long as the aggregate principal amount of the Bonds does not exceed \$120,000,000 and the final maturity date is no later than January 1, 2025. Bids must be on an all or none basis. The clerk of the county council is directed to cause an abridged Notice of Bond Sale to be published at least once in a financial newspaper or journal of general circulation throughout the United States and to provide such other notice as he/she may deem advisable.

The County Finance Manager is hereby authorized to withdraw Bonds from sale (and to revise the Official Notice of Bond Sale accordingly) in the principal amount corresponding to the amount allocated to refund the Refunded Bonds if the amount of net present value savings to be derived from such refunding would, in such officer's judgment due to market conditions, be less than required in the county's best interest to proceed with such refunding at this time.

Upon the date and time set forth in the Official Notice of Bond Sale for the receipt of bids, the clerk of the council, or his designee, shall open the bids. The County Finance Manager shall cause the bids to be mathematically verified and shall report to the council regarding the bids received. The council shall approve the sale of the Bonds and establish the date, interest rates, and

redemption provisions of the Bonds by motion. The County Finance Manager shall determine the principal maturity amounts and aggregate principal amount of the Bonds thereafter in order to accomplish the plan of refunding set forth in Section 20 hereof; provided, that the aggregate principal amount of the Bonds shall not exceed \$120,000,000, and the County Finance Manager shall report to the council within 24 hours of the time the bids are due regarding the principal maturity amounts and final aggregate principal amount of the Bonds.

SECTION 27. Delivery of Bonds. Following the sale of the Bonds, the county shall cause definitive Bonds to be prepared, executed and delivered, which Bonds shall be typewritten, lithographed or printed with engraved or lithographed borders.

If definitive Bonds are not ready for delivery by the date established for closing, then the County Finance Manager, upon the approval of the purchasers, may cause to be issued and delivered to the purchasers one or more temporary Bonds with appropriate omissions, changes and additions. Any temporary Bond or Bonds shall be entitled and subject to the same benefits and provisions of this ordinance with respect to the payment, security and obligation thereof as definitive Bonds authorized thereby. Such temporary Bond or Bonds shall be exchangeable without cost to the owners thereof for definitive Bonds when the latter are ready for delivery.

SECTION 28. Preliminary Official Statement Declaration. The county has been provided with copies of a preliminary official statement (the "Preliminary Official Statement"), prepared in connection with the sale of the Bonds. For the sole purpose of the Bond purchaser's compliance with Securities and Exchange Commission Rule 15c2-12(b)(1), the county "deems final" that Preliminary Official Statement as of its date, except for the omission of information on offering prices, interest rates, selling compensation, delivery dates, any other terms or provisions required by the county to be specified in a competitive bid, ratings, other terms of the Bonds dependent on such matters and the identity of the Bond purchaser.

SECTION 29. Approval of Official Statement. The county executive or the County Finance Manager is hereby authorized and directed to review and approve on behalf of the county an official statement with respect to the Bonds to be prepared prior to the sale thereof.

SECTION 30. General Authorization. The appropriate county officials, agents and representatives are hereby authorized and directed to do everything necessary for the prompt sale, issuance, execution and delivery of the Bonds, and for the proper use and application of the proceeds of the sale thereof.

- 7. Courthouse Improvements. The project shall consist of improvements to the first, fourth and twelfth floors of the King County Courthouse, including information and communications equipment.
- 8. <u>Public Safety Facility</u>. This project shall consist of the acquisition of a facility to house public safety laboratories and the Marine Patrol.
- 9. Geographic Information System. The project shall consist of the acquisition of hardware and development of software for the Geographic Information System (a county-wide system relating to streets, utilities and other land uses) and a Wide Area Network plan. The project provides support to the consolidation of King County and Metro, and will provide an integrated system for a wide array of county functions.

Arts and Historic Preservation. The project shall consist of a capital grant to fund a portion of the construction costs of a theater in Issaquah, Washington to be owned and operated by the Village Theatre, a nonprofit corporation described under Section 501(c)(3) of the Code.

 - Conservation. This project shall consist of the acquisition of real property in the Cedar River basin for the purpose of conserving natural habitat.
- Educational and Cultural Facilities. This project shall consist of capital grants to the Pacific 5. 15 Science Center for the construction of educational facilities and related space and to the Paramount Theatre for remodeling. 16

County Information Systems. 6.

- This project shall include the acquisition of hardware and software for the Assessor's Data Processing System, General Ledger System development and Information Technology Plan development.
- This project shall also include an Executive-Legislative Local Area Network to ь. support the communications needs of the new Council and provide an interface with the Executive's office, the Budget office and the Department of Executive Administration.
- Courthouse Improvements. The project shall consist of improvements to the first, fourth 7. and twelfth floors of the King County Courthouse, including information and communications equipment.
- Public Safety Facility. This project shall consist of the acquisition of a facility to house 8 public safety laboratories and the Marine Patrol.
 - Geographic Information System. The project shall consist of the acquisition of hardware and development of software for the Geographic Information System (a county-wide system relating to streets, utilities and other land uses) and a Wide Area Network plan. The project provides support to the consolidation of King County and Metro, and will provide an integrated system for a wide array of county functions.
