AN ORDINANCE relating to Zoning, amending Ordinance No. 10870, Section No. 388 and K.C.C. 21A.16.030, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 10870, Section No. 388 as amended and K.C.C. 21A.16.030 are each hereby amended to read as follows:

Land use grouping. In order to facilitate the application of this chapter, the land uses of K.C.C. 21A.08 have been grouped in the following manner.

- A. Residential development shall refer to those uses listed in K.C.C. 21A.08.030, except those uses listed under Accessory uses, provided:
 - 1. Attached/group residences shall refer to:
 - a. townhouses, except as provided in Subsection
 - ((a))b. apartments;
 - ((\(\frac{b}{c}\))\(\frac{c}{c}\). senior citizen assisted;
 - ((e))d. temporary lodging; ((and))
- $((d))\underline{e}$. group residences other than Type I community residential facilities;
 - ((e))f. mobile home parks; and
 - 2. Single family development shall refer to:
- a. residential subdivisions, including attached and detached dwelling units on individually platted lots; ((and))
- b. any detached dwelling units located on a lot; and
 - ((b))c. type I community residential facilities.
