AN ORDINANCE relating to no shooting areas, establishing a no shooting area on and near Stossel Creek Road, and adding a new section to K.C.C. 12.68.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The shooting of firearms is prohibited and a no-shooting area is established on and near Stossel Creek Road, within the Stossel Creek and Stillwater voting precincts, comprising portions of Sections 13, 14, 15, 22, 23, 24, 25, 26 and 27, Township 26 North, Range 7 East W.M., King County, Washington described as follows:

A. Between 360th Avenue Northeast and its extended center line on the east, Northeast 130th and its extended line on the south, 2,000 feet west of Kelly Road on the west, Northeast 145th and its extended center line on the north.

B. Nothing in this ordinance shall prohibit the

There have been drug busts east of where we live on 351st avenue N.E. and county officers, if they may, can give evidence of plenty of drunken parties.

We are the last street to the east until the approach to Sultan and there are no other outlets west except Stossel Creek Road where we live.

Their return is not enjoyable as they drive like madmen and shoot like the wild west. Often we feel they aim to kill.

No sign is sacred whether it is street or school bus stop ahead or telephone junction box. They could injure themselves when shooting thee junction box but they don't think.

They aim at our property and the house is not far enough away to be safe from bullets coming through the walls.

On Kelly Road just the other day a family had a bullet come through their window and that same house has spent bullets dropping into their yard and onto the roof of their house from the hill above and to the east.

Deer come onto our propertys which is attractive to poachers. Official no shooting signs might discourage that but if we put up no hunting private property signs it would be an open invitation

Children play on the hill along 348the street and are in danger because shooting goes on along the hillside. Somebody is going to shoot a child. Not all target practicing is done by experts.

Anyone on horse, bike, car, motorbike, running or hiking can fall victim.

Night after night we suffer from loss of sleep because they feel a compulsion to expend all their bullets after their parties.


They use automatic, semi-automic, rifles, shotguns and pistols We are sorry to have to add to your work time and full agendas but we are all afraid for our lives.
