ORDINANCE NO. 11711

AN ORDINANCE approving the merger of King County Water District No. 49 into Southwest Suburban Sewer District for the purpose of creating one consolidated special purpose district to provide both water and sewer service.

#### STATEMENT OF FACT:

- A notice of intention proposing the merger of King County Water District No. 49 into Southwest Suburban Sewer District for consolidating sewer services was filed with the county council effective February 13, 1995.
- Southwest Suburban Sewer District, by Resolution No.95-1, and King County Water District No. 49, by Resolution No. 95-1104, have each agreed that the merger would be conducive to the public health, welfare and convenience of, and be of special benefit to, the lands within both Districts, have signed a merger agreement, and have agreed that Southwest Suburban Sewer District would be the designated SEPA Lead Agency.
- 3. Southwest Suburban Sewer District filed a Determination of Nonsignificance dated January 19,1995 on the proposed merger.
- 4. The county council held a public hearing on the 13 day of March, 19 95 and has considered the criteria set forth in R.C.W. 56.02.040 and R.C.W. 56.02.060.

<u>SECTION 1</u>. The merger of King County Water District No. 49 , described in Attachment A, into Southwest Suburban Sewer District, is approved. This proposed merger is consistent with R.C.W. 56.02.040 and R.C.W. 56.02.060.

SECTION 2. Southwest Suburban Sewer District is the appropriate entity to provide water and sewer service to the area proposed to be merged.
